MIND, BODY, AND THE G.P.

Psychophysiologic Approach in Medical Practice. By William W. Schottstaedt, M.D. (Pp. 352. 60s.) Chicago: The Year Book Publishers, Inc. London: Interscience Publishers, Ltd. 1960.

I do not know if anyone can keep up with the flow of publications on even any single subdivision of a scientific subject such as psychological medicine. Nor do I know to what extent works on this subject from across the Atlantic are written to supply a need, or to what extent they are produced by way of theses or of self-justification. Tremendous, too, is the dominance of fashion in American psychiatry: I do not know whether the wave of exploitation of poor Sigmund Freud's theories is still rushing up the American shore, or whether it is withdrawing at last to the sound of hissing and rustling, as waves do.

This book is written by an associate professor in the University of Oklahoma to introduce students and graduates to psychological and somatic actions and interactions as they may be met in general practice—clearly a useful object. It is not Freudian, so it is not in conformity at least with yesterday's fashions. It is a sincerely written book and is full of information and illustration on the simple meanings of physiological mechanisms, constitutional make-up, mental and emotional mechanisms, and conflict. Its last chapters are on interviewing, and its first one is on stress—surely something of a plunging in at the deep end?

One thing is certain, however. Much good effort in America is spoilt by verbosity, and this book is no exception. It does not take the form, in this case, of the polysyllabic logorrhoea of those who are seeking to impress; it is rather a voluminous or Teutonic long-windedness that makes an elementary manual of instruction take up more than 300 pages of not very readable stuff—hardly, I think, the vade-mecum elect of the psychologically inclined larval G.P.

Worthy, if diffuse, then, this work may be. But this is not all. Nowhere in all its pages is there any mention of projection mechanisms—displacement, yes, but projection, no. There is no mention whatever of all that vast sour labyrinth of thought processes that underlies the huge field of paranoid illness—surely almost a half of all that of abnormal psychology. Paranoid projections may not, perhaps, give rise to as many somatic symptoms as do the other mechanisms in abnormal psychology, yet to attempt to summarize mental mechanisms while ignoring projection really cannot be condoned, and a work that leaves it out cannot be regarded as a comprehensive study of its subject.
