evidence of early types of fossil man in the world by no means indicates "clearly" an African origin. After debating this matter, he turns to more recent aspects of African development and suggests "as a social anthropologist" that the mental and psychological differences between major human groups such as the European and Negro are greater than the physical differences. Unfortunately, we are left to find the evidence—no easy matter for most of us.

The second part is very much a repetition of the first, though at times it somewhat modifies the previous lecture. For example, at first we learn that Zinjanthropus was "apparently making tools to a set and regular pattern," but later he says, "I admit I am no longer quite so certain." A number of statements, seemingly incontrovertible, are in fact very debatable. For example, the taxonomic importance of the morphological differences between the premolar of the Zinjanthropus juvenile and the South African Australopithecines is questionable in view of the variability to be seen in this tooth within and between natural breeding populations of modern higher primates.

A number of printing errors are present, shamefully including four instances of taxonomic nomenclature. This is not a book I can recommend.

this element of the Health Service was now costing. Last July it was said to be £100m. a year. Was the Minister satisfied that the patient was getting the maximum benefit from this reduction ? Mr. POWELL said he could not give the total cost off-hand, but the reduction in price since the new scheme came into effect was about £4m. a year. None of the reductions had operated to the dissatisfaction of any patient; the contrary was probably the case.

## Vaccination Fees

Mr. PAVITT asked the Minister on May 18 what action he proposed to take to reimburse general practitioners in cases where they had given vaccinations on the understanding that a payment of 5s. per vaccination would be made for all categories of patient, only to find that no payment or payments for restricted categories would be made. Miss PITT: "None.'

Mr. PAVITT asked what recent change had been made in the position whereby local health authorities paid a fee of 5s. to a general practitioner in respect of each vaccination notified. Miss PITT said there had been no change. Subject to any general requirements, each local health authority decided the categories of vaccination for which it asked general practitioners to supply individual records. A fee of 5s. was payable by the authority for each such record. Mr. PAVITT also asked whether the sums deducted from the general practitioners' central pool in respect of fees received from local health authorities were refunded to those authorities making the original payments. Miss PITT: "No."

# Vaccination Deaths in Smallpox Contacts

Commander J. S. KERANS (The Hartlepools, Con.) asked the Minister of Health on May 7 how many of those who recently died of smallpox in the United Kingdom had been vaccinated in the last three years. Miss FDITH PITT, the Parliamentary Secretary, stated that two immigrants died, both of whom held on arrival valid international certificates of recent vaccination. Of the 24 United Kingdom residents who died, none had been vaccinated or revaccinated within the previous three years. except eight who were vaccinated or revaccinated after contact with smallpox.

## Maternity Service Regulations

Dr. ALAN GLYN (Clapham, Con.) asked the Minister what proposals he had to amend the terms of service of general practitioners providing maternity medical services. Mr. POWELL: "In presenting consolidating regulations shortly I propose to take the opportunity to eliminate the specification of certain detailed clinical requirements. The change will not affect the doctor's obligation to provide all necessary services."
