

opportunities for a wide range of topics to be discussed. This made for much more interest than if attention had been fixed entirely on the main theme. For instance, the first two papers emphasized that we need more clinicians who are specially trained and experienced observers of the function of the nervous system in infancy and childhood, and there seems little doubt that paediatric neurologists will soon be a recognized group in paediatrics. Then followed several papers that dealt in particular with spinal cord functions and mechanisms, and some of Sherrington's remarkable experimental work had to be mentioned. This was of special interest to me—if I may be allowed a personal note—because I was a medical student under his tuition at the time and he was good enough to allow me to see some of these experiments. Then followed three papers of highly specialized character, dealing with the influence of the thyroid gland upon the central nervous system, and biochemical and metabolic studies of the developing brain. I confess that I was out of my depth, but I understood enough to realize that herein lay great possibilities for the future.

Subsequent papers dealt mainly with clinical aspects of child development and cerebral palsy, and they contained a great deal of practical usefulness as well as plenty to interest the more academic mind. This blending of theory and practice was just what was needed to maintain balance; and all the papers showed evidence of a most commendable modesty, as one frequently finds when speakers are real authorities.

As a clinician I feel that special attention should be called to the six papers grouped under the heading "Parents, Patients, and Doctors." They reach the high-water mark of excellence and should be read and pondered by everybody concerned with chronic handicaps in childhood—no matter what form it may take.

The book is well produced and has some useful illustrations. Altogether a good report of a remarkable congress. Let us hope there will be more.

require security for costs (by way of payment into court) to be given by an appellant who would be unable through poverty to pay the costs of the appeal if unsuccessful. However, this general practice is applied only in a restricted way to appellants who are legally aided. Section 12(2) of the Legal Aid and Advice Act, 1949, provided that the Lord Chancellor might make regulations to define the cases in which and extent to which a person receiving legal aid may be required to give security for costs. No such regulations have yet been made, and in the absence of them the Court of Appeal decided eighteen months after the passing of the Act that security for costs would be ordered against an assisted person only in special circumstances.<sup>1</sup> Mere poverty of the appellant is not a special circumstance. It was decided in 1953<sup>2</sup> and 1954<sup>3</sup> that if the assisted person had been ordered to make a substantial contribution to the costs in the court below that might be a "special circumstance" and the Court of Appeal could order the appellant to pay money into court by way of security for costs as a condition of proceeding with his appeal.

#### Clarification of Position

The position is still the same to-day. There are still no regulations on this point and the authorities cited above are still good law, though the Court of Appeal has recently put the rule slightly differently and in so doing has clarified the position. On May 7 the Court of Appeal (the new Master of the Rolls, Lord Denning, presiding) stated the principle that the Court must endeavour to avoid hardship to the unassisted litigant while on the other hand not ordering a security for costs which would be so far outside the appellant's means as to prevent him appealing altogether (*The Times*, May 8). In the case before the court<sup>4</sup> the legal aid certificate granted to the assisted litigant assessed his disposable capital at £323, and the maximum contribution ordered in respect of the trial at first instance was £207 10s., leaving a balance of a little over £100 disposable capital in the litigant's hands. The assisted litigant lost his case, as defendant, at first instance and wished to appeal. Lord Denning stated that: "If the Court, considering the circumstances of the case, could think of a sum which should fairly be put up by the appellant without depriving him of his appeal, it was right that the Court should order it."

The Court ordered the legally aided litigant to pay into court £100 as security for the costs of the appeal within 14 days, in default of which the appeal should be dismissed. It should be added that in the court below the successful plaintiffs had incurred costs estimated at £1,500.

## Vital Statistics

### Venereal Diseases

In England and Wales, during the quarter ending December 31, 1961, 1,182 new cases of syphilis were reported as attending the clinics, compared with 972 in the same quarter the previous year. Of these, 355 (228 in the corresponding quarter last year) were classified as primary, secondary, or latent in the first year of infection. Four cases of congenital syphilis in children aged under 1 year were reported and 84 in persons over that age. New cases of gonorrhoea (with corresponding 1960 figures in parentheses) numbered 8,634 (8,584), of chancroid 48 (49), and of non-gonococcal urethritis (males only) 5,714 (5,053).—*Monthly Bulletin of the Ministry of Health*, May, 1962.

### Central Register of Drug-resistant Cases of Tuberculosis

The Tuberculosis Reference Laboratory at Cardiff, in collaboration with the Statistics Branch of the Ministry of Health, is to set up a central register of drug-resistant cases of tuberculosis. It will record and follow up details of patients from whom tubercle bacilli have been grown which show significant resistance to isoniazid, P.A.S., and streptomycin. It is expected that this register will provide much useful information about the overall incidence, pattern, and distribution of drug resistance. The three types of case to be notified are (1) those in which tubercle bacilli show resistance to standard drugs on primary isolation; (2) those in which tubercle bacilli appear to be developing resistance during treatment at home or in hospital; and (3) those in which a positive sputum or culture persists after six months' treatment with standard drugs but in which drug sensitivity is apparently normal or is not known.—Memorandum H.M. (62)40.

### Leading Causes of Death in Industrialized Countries

Heart disease, cancer, and "strokes" consistently took first, second, and third places respectively, from 1954 to 1959, among the ten leading causes of death in most industrialized countries of the world. Motor-vehicle and all other accidents took fourth place in most countries, except Sweden, England and Wales, and Northern Ireland, where influenza and pneumonia were slightly more deadly than accidents. From the age of 1 to 15 years accidents were by far the most important single cause of death. Between the ages of 5 and
