do not contain the detailed items listed: these appear in working drawings. On p. 262 it is said that central sterilizing is not applicable to operating theatres, which is contrary to current planning.

On the whole, the content of the work is descriptive rather than critical, thus making it more suitable as a general introduction to the subject than as a book of reference for planners and senior administrators. It is refreshingly well written in language devoid of the tortuous officialese so common in a book of this kind.

## COMMON SENSE ABOUT PSYCHOTHERAPY

Aspects of Psychotherapy. By I. Atkin, M.D.(Lond.), D.P.M. (Pp. 103+vii. 10s. 6d.) Edinburgh and London: E. and S. Livingstone Ltd. 1962.

Though written for psychiatrists on the brink of their career and for general practitioners, this small volume of essays should be read by every psychiatrist who can get his hands on it. Dr. Atkin is never didactic and yet he is a teacher; for he writes out of his perceptive experience. "Dostoevsky, Prophet of Modern Psychology," the last chapter, should be read first. How many of us knew that Dostoevsky anticipated some familiar concepts much prized by the schools of psychology? He did not use the word "unconscious," but the notion is clearly described. So, too, is the rationale of "free association." And Dostoevsky died in 1880.

Next should be read the essay on "Art Therapy." It is too short, but Atkin knows his subject and gives an excellent summary of the principles behind the art therapies—music, the graphic arts, sculpture, drama, and so on. Emotional disturbances, from which the majority of the mentally sick suffer, are alleviated by the expression of feelings in the various types of art.

"The Psychology of Shock Therapies and of Leucotomy" should be pondered by psychiatrists committed to the use of physical methods, and the partisan of exclusively psychological procedures would profit by reading "Psychotherapy and the Trainee Psychiatrist." Naturally enough the trainee may well be puzzled to observe adherents of the three main schools of psychotherapy elucidating differing psychodynamic explanations and obtaining about the same percentage of cures.

With experience, let us hope, we shall learn that "each patient is a law unto himself and artistic flexibility in treatment is the only rule to be followed" in the art of medicine.
