## Tropical Splenomegaly

**Tropical Splenomegaly.** By A. K. Basu, M.S.(Cal.), F.R.C.S., and B. K. Aikat, M.D., D.C.P., Ph.D. (Pp. 195 + xii; illustrated. 50s.) London: Butterworths. 1963.

This monograph is concerned with a disorder that poses difficult problems and affects many thousands of people throughout tropical regions. It is based on a study of 190 patients with splenomegaly, from 99 of whom

the spleen was removed. Careful haematological, biochemical, and radiological investigations, including oesophagography and splenoportal venography, were carried out. At operation specimens of liver were removed for histological and other studies, and estimations of the portal venous pressure were made. The reports of the studies are amplified by 43 tables and 120 figures, including many photomicrographs and photographs of splenoportal venograms.

Anaemia was a feature of the cases. It was notable in those patients who had liver damage, and this could not be explained—as it could in those cases with extrahepatic obstruction—by frequent haemorrhages. After splenectomy the clinical state of the patients improved and the pathological features of the liver regressed, and one of the conclusions of the authors is that the anaemia, leucopenia, and thrombocytopenia were not due to local causes but to the inhibitory influence of the enlarged spleen on the bone marrow. They therefore considered that the spleen was exerting an adverse influence on hepatic repair. Experiments with rats were carried out with methyl-cellulose to blockade the reticulo-endothelial cells of the

spleen and thereby reduce their inhibitory effect on liver regeneration. The results indicated that, though the spleen normally exerts an inhibitory control on the regenerative capacity of the liver, this effect may be enhanced when there is hyperplasia of the splenic reticulo-endothelial cells induced by liver injury.

Malaria was found to be a relatively unimportant cause of splenomegaly in this selected series, and it was thought that a virus hepatitis was the prime factor in most cases. While this may have been true for this series it is perhaps unjustifiable to apply to it the term tropical splenomegaly in view of the diversity of other causes which are responsible elsewhere. Thus, Egyptian splenomegaly is almost wholly a result of schistosomiasis, and in other regions malaria may play a much more important part than it did in these 190 patients.

Not all the illustrations are necessary and they have no doubt added to the cost of this quite slim volume. The problem of tropical splenomegaly is far from being solved, but this work forms a valuable contribution towards its solution.
