publication is based on the papers presented to a congress of Scandinavian neurologists in 1964, and the eleven topics discussed include echo encephalography, isotope encephalography, cerebrospinal-fluid chemistry, nerve conduction and neural biopsy methods, and the techniques of measuring blood flow. In addition to their practical value in diagnosis these methods introduce new tools for research.

## Speech Problems

The set of volumes which constitutes the "Foundations of Speech Pathology Series" is designed to serve as the nucleus of a library for students of speech pathology and audiology and for practising clinicians. One outstanding feature of the volumes is that in addition to providing the essential informa-

tion about his subject each author has clearly indicated useful references by means of paragraphs in heavier type throughout the book. Although each volume in this series is complete in itself, the intention is that any instructor should combine several volumes to form a basis to the course he teaches. They may also be used with advantage for collateral study.

Dr. Nancy Wood, Research Director of the John Tracey Clinic, Los Angeles, describes and discusses the various causes, both organic and functional, of delayed development of speech and describes methods of treatment. She makes no claim to any new ideas but states that what she has written has been gleaned from numerous conversations with directors of clinics, supervisors, classroom teachers, researchers, and clinicians, as well as information gained from discussions with the parents of patients.

The book written by Martha E. Black, who is consultant in Speech Correction, Division of Special Education, Illinois State, describes the establishment, organization, and administration of speech-therapy programmes in the schools. The writing of the book was prompted by the author's increasing awareness of the need for a better preparation and training of speech therapists working in schools. The author emphasizes the importance of close co-operation with all available professional resources, and especially with the classroom teacher. The clearly described steps in gaining proficiency in speech therapy are of considerable practical value. An extensive bibliography includes many references to branches of child study and related subjects other than speech.

Dr. F. B. Robinson, Professor of Speech and Director of the Speech and Hearing Clinic, Miami University, Ohio, presents the current theories of stuttering, or stammering -the term most frequently used in Great Britain. As one might expect, he admits that the cause of stuttering remains somewhat of a mystery, but that the condition almost certainly has multiple origins. The author explains how stuttering changes in form and severity as hesitant speech becomes a source of anxiety and of feelings of frustration. Examples of clinical cases are presented to illustrate individual differences together with suggested approaches for treatment. Dr. Robinson considers that secondary stuttering would develop rarely if the early signs of stuttering could be prevented from becoming the focus of feelings of intense concern.

The Director of the Speech and Hearing Clinic, University of Illinois, Dr. J. J. O'Neill, discusses the personality, intelligence, and academic abilities of the "hard of hearing." He describes the physics of sound, the anatomy and physiology of the ear, the causes of deafness, the various types of loss of hearing, methods of evaluation of hearing, including medical and audiological diagnostic procedures, and the various means of alleviation and compensation for the defect. The therapeutic factors are outlined in terms of the extent of the hearing loss and include descriptions of lip-reading, auditory training, and the use of hearing-aids.

This series of small volumes constitutes a valuable addition to the library of everyone concerned with the problems of speech disorders.
