biologically literate. This slim volume is all the equipment he needs.

## Therapeutic Tool

Bone Marrow Transplantation. By D. E. Pegg. (Pp. 192+vii. 40s.) London: Lloyd-Luke. 1966.

The title of this work indicates a monograph which might be of interest to one or two people in a few specialized centres in the world. Nothing could be further from the truth. This is a book which should find its place on the shelves of every department of physiology, pathology, and medicine in the world.

Dr. Pegg has enhanced his reputation considerably by the production of this almost pocket-size volume. The 192 pages are clearly written and well illustrated. There are no less than 744 references, and this gives some idea of the diligence of the author in drawing together the basic scientific information involved in the process of bone marrow trans-

This slim volume is plantation and relating it to the clinical eeds. therapeutic attempts so far made.

The first of nine chapters deals not only with preliminary considerations of terminology and experimental methods of bone marrow study but briefly reviews the history of early experiments in the use of marrow therapeutically. The author then goes on to devote the next three chapters to exploring our knowledge of the effects of ionizing radiations and the steps taken towards successful experimental protection of animals and man by bone marrow transplantation. He states categorically in a chapter on allogeneic bone marrow infusion (infusion of marrow from unrelated donors) that whole body irradiation or massive chemotherapy cannot be justified as treatments by employing this method. With regard to syngeneic bone marrow transplants, 13 that have been carried out between identical twins are reported. Seven such transplants have been inpatients with aplastic anaemia and the others inpatients with acute leukaemia treated by whole body irradiation. The aplastic anaemias were the only cases where this type of treatment seemed justifiable, as in

spite of irradiation leukaemia recurred in all but one of the six cases reported, and in that case the patient died with marrow aplasia on day 20. The following chapter on autologous bone marrow transplantation in man concludes that the disappointing results so far obtained with this possible addition to cancer treatment techniques are probably due to a failure to recognize the situations in which they might reasonably be expected to help.

By the end of chapter VII the reader feels that the short term therapeutic future of marrow transplantation in man is bleak except in a few rare cases. The last two chapters of this monograph, however, by reviewing the present state of technique of bone marrow transplantation and low temperature storage bring encouragement for the future. Such is the diligence and hopefulness of the researchers that when we learn to recognize which patients are most likely to be helped, then a useful therapeutic tool will be ready for use.

Perhaps the most important aspect of all this work is its by-product—the study of lowtemperature biology.
