Chronic Disease Epidemiology

Epidemiological Approaches to the Study of Cancer and Other Chronic Diseases. Edited by William Haenszel. (Pp. 465 + xi. No price given.) Bethesda, Maryland : U.S. Department of Health, Education, and Welfare. 1966.

This monograph was issued as a memorial to the work of Harold Dorn, whose death in 1963 brought to a premature end a distinguished career in demography and medical statistics. It has now been recognized, thanks to the efforts of Dorn and others, that studies of the aetiology and prognosis of chronic

disease can be made only on a prospective (longitudinal) basis. A greater effort is required than for cross-sectional prevalence studies, and the most efficient methods have still to be worked out. Because Dorn devoted so much of his energies to these problems, it was thought fitting that papers selected for this monograph should be orientated to them.

The first paper appropriately is devoted to the first results of Dorn's own observations of the mortality among Government life-insurance policy-holders, a study begun in 1954 and designed to show the effects of smoking on health. This covers eight and a half years of accumulated data. Other papers on prospective studies include one by Doll and Bradford Hill on coronary thrombosis in relation to smoking, as observed in their classic follow-up of British doctors, and two papers by E. C. Hammond (one in association with L. Garfinkel) on the effects of smoking on health. There is a group of papers concerning the British-Norwegian migrants' study of mortality—that is, comparing the mortality of migrants and native-born in Great Britain, Norway, and the United

States. The aim of these studies is to assess the roles of host characteristics and environmental factors in levels of risks for cardio-respiratory disease and cancer. This is a massive project of data-management, and is of great methodological interest, apart from the findings themselves, which are also relevant both to the problem of population mobility and to the causation underlying international variations in mortality. Other papers are concerned with case-control studies of leukaemia, the use of cancer registers for prevalence and prognostic studies, and problems in the recording and analysis of causes of death (including a paper by Dorn himself on underlying and contributory causes of death).

As the editor William Haenszel remarks, these papers, though selected as connected with Dorn's work, are also "a fair sample of the present state of chronic disease epidemiology." By indicating problems still unsolved they emphasize the loss of one who was in the forefront of progress in this field.
