Society for Protection of Unborn Children

A mass rally sponsored by the Society for the Protection of Unborn Children was held in Manchester on 25 March. People came from many parts of Britain for speeches against the present Abortion Act. Afterwards there was a silent march to the Free Trade Hall, where white flower badges—symbolic of aborted fetuses—were dropped into containers.

Families of Handicapped Children

The Government's fund of £3m to help parents of severely handicapped children (see *B.M.J.*, 6 January, p. 58) is to be administered by the Joseph Rowntree Memorial Trust. The first group of families eligible to make application to the Trust are those with children between 10 and 15 years old, and applications can be made from 2 April. It is hoped that all age groups will be included by 1 August. Clerks of all county councils and county borough councils have been sent a circular D/C 178/3 giving details of the scheme thus far.

Chair of Rehabilitation Studies, Edinburgh

In addition to the grant already announced (17 March, p. 687) the Thistle Foundation has given £50,000 to this chair, and £500 a year for five years has been donated by the Hugh Fraser Foundation.

British League against Rheumatism

The Arthritis and Rheumatism Council, the British Association of Rheumatology and Rehabilitation, the British Rheumatism and Arthritis Association, the British Council for Rehabilitation of the Disabled, the Heberden Society, and the Society for Back Pain Research have come together to form the British League against Rheumatism. Its inaugural meeting was held on 28 March at the Royal College of Physicians, London. The president of the new body is Dr. R. M. Mason.

Teaching the Mentally Handicapped

A building designed expressly for training teachers of the mentally handicapped was opened in Birmingham recently by the Queen Mother. The Frank Price Building in the Westhill College of Education has a system of one-way observation rooms enabling students to watch unseen while psychiatrists and trained teachers deal with their patients and pupils. The annual student intake is 25 for a three-year course. The building was financed by the National Society for Mentally Handicapped Children through a campaign launched by Sir Frank Price, mayor of Birmingham in 1964.
