# Eyes at the Westminster

Just 250 years ago William Cheselden performed the first ophthalmic operation to be done in the then recently opened Westminster Hospital. The leading oculist of his day thus began an unbroken succession of eye surgery at the Westminster. Four years after Cheseldens' arrival Thomas Hope was also appointed oculist to the hospital, so that 50%of the consultant surgeons there were then opthalmologists. These and later events are commemorated in a pamphlet produced privately by Mr. P. Trevor-Roper, consulting ophthalmic surgeon to the hospital.
