assist those whose first language is Welsh. The Secretary of State for Wales has decided that "consent to treatment" forms will in future be printed bilingually, and it is suggested that signs and notices, and publications—where practicable and in response to demand-should be printed in both English and Welsh. Facilities should also be provided for hospital patients who wish to listen to Welsh broadcasting services, and to attend activities conducted in Welsh. Hospitals and clinics should have a Welsh speaking member of staff in attendance to answer oral inquiries, particularly those from the young or the elderly who may have difficulty in speaking and understanding English.

Health Education

The role of general practitioners in health education is to be considered by a working party with representatives from the Health Education Council, the Royal College of General Practitioners, and the Scottish Health Education Unit. The working party wants to collect information on the extent to which general practitioners already promote health education in their practices. Any doctor who would like to give details of his own experience is asked to contact the chief medical officer of the Health Education Council, Dr. A. J. Snake Bite Treatment

Dr. Alistair Reid, in the Department of Tropical Medicine, University of Liverpool, has received a grant from the Medical Research Council of £26 509 for a three-year study of the effect of viper venoms. The study is to cover the adder, the only naturally occurring venomous snake in Britain, and the saw-scaled or carpet viper, said to be the most dangerous snake in the world to man and found in tropical regions of the Middle East, Africa, and India.

The work will be done in collaboration with the Ahmadu Bello University in Northern Nigeria.

Prisons and Prisoners
