## Nation's health

A falling birthrate, smaller families, and fewer abortions are the main trends seen in the vital statistics analysed by Sir Henry Yellowlees in his CMO's report for 1974, *On the State of the Public Health* (HMSO price £1.70). The birth rate for the year of 13/1000 was an unprecedented low level, says the report, adding that "among recently married couples there is evidence of a conscious desire to postpone starting a family and space their children." However, the perinatal and infant mortality rates in Britain were still behind many of our European neighbours: lower perinatal mortality was recorded by Bulgaria, Czechoslovakia, Denmark, Finland, France, East Germany, Iceland, the Netherlands, Norway, Poland, Rumania, Sweden, and Switzerland.

## Resignation honour

## Mental hospital statistics

Admissions to mental hospitals have risen progressively in the last decade, according to the DHSS publication *Psychiatric Hospitals and Units in England—Inpatient statistics from the Mental Health Enquiry for the year 1973* (HMSO price £2.95). The 1973 figure of 175 000 was 20 000 up on that in 1964. First admissions have shown a recent slight fall, while readmissions have continued to rise. The proportion of patients admitted to psychiatric units in general hospitals has risen, and now accounts for 23% of admissions.

Alcoholism shows the most marked upward trend among the diagnostic categories—the increase has averaged 12.5% a year—compensated by a decline in admissions for psychoneurosis.

## Inquiry into Prescription Pricing Authority seeks evidence

An independent inquiry is being arranged into the functions, constitution, and organisation of the Prescription Pricing Authority. This inquiry was prompted, says the DHSS, by recent delays in payments to chemists and dispensing doctors.

Mr R I Tricker, director of the Oxford Centre for Management Studies, will conduct the inquiry assisted by Mr J Charlton, nominated by the Pharmaceutical Services Negotiating Committee, and Dr W G A Riddle, nominated by the British Medical Association. The

inquiry would welcome the views of individuals who wish to submit evidence, which should be sent by 16 July to the secretary, Inquiry into the Prescription Pricing Authority, Room 523, Hannibal House, Elephant and Castle, London SE1.
