

board, and also that a training course with a national examination should be provided for the medical representatives of firms. Grants from drug firms to finance postgraduate meetings, says the report, should be allowed provided that all the arrangements are approved. Science and the media

Though scientists are usually treated with respect by the media there has been a slight but definite change, with a more critical stance on the part of some correspondents, point out Greta Jones, Ian Connell, and Jack Meadows in *The Presentation of Science by the Media*. In medical items (which formed the bulk of the science coverage) in newspapers there was often a sense of unease, they found, with emphasis on ethical issues raised by medical practice and research. They absolve television of bias, both in science feature programmes and in the more confrontational interviews of current affairs programmes; but they discuss and illustrate in detail the transmutations of material achieved during production, which tend to give an unrealistically tidy picture of opinion and the development of knowledge. The report is published at £2.50 (£3.00 for overseas) by the Primary Communications Research Centre, University of Leicester, Leicester LE1 7RH.

Instructions to authors

The following are the minimum requirements for manuscripts submitted for publication.

(1) **Typing** should be on one side of the paper, with double or triple spacing between the lines and 5-cm margins at the top and left-hand side of the sheet.

(2) **Two copies** (or preferably three) should be submitted.

(3) **Spelling** should conform to that of *Chambers Twentieth Century Dictionary*.

(4) **References** must be set out in the style used in the *BMJ*, and their accuracy verified before the manuscript is submitted.

(5) **SI units** are used for scientific measurements. In the text they should be followed by traditional units in parentheses. In tables and illustrations values are given only in SI units, but a conversion factor must be supplied. For general guidance on the International System of Units, and some useful conversion factors, see *The SI for the Health Professions* (WHO, 1977).

(6) **Authors** should give their names and initials, their current appointments, and not more than two degrees or diplomas. Each author must sign the covering letter as evidence of consent to publication.

(7) **Acknowledgments** will *not* be sent unless a stamped addressed envelope or an international reply coupon is enclosed.

(8) **Detailed instructions** are given in the *BMJ* dated 7 January (p 6).
