New rehabilitation assessment unit

Patients with any severe locomotor disability should be helped by the Graham Hill Rehabilitation Unit, opened this week by the Prince of Wales at the Royal National Orthopaedic Hospital, Stanmore, Middlesex. Financed partly by an appeal in memory of the racing driver Graham Hill, the unit consists basically of a two-bedroomed house where patients (with their relatives) can live before discharge, learning under the guidance of therapists how to cope with changed abilities and being assessed so that special adaptations can be made at home. The unit will also encourage research and teaching on the assessment and management of severe disability for doctors and other health professionals. At the opening the Friends of the Hospital launched a national appeal for £1 m for more teaching facilities, accommodation for relatives, and specific topics of research.

Imperial Cancer Research Fund

The Imperial Cancer Research Fund is giving £1.25 m to finance work at the Institute of Cancer Research: Royal Cancer Hospital, Sir Eric Scowen announced at the annual meeting of the ICRF's governors last week. The *Annual Report and Accounts 1978*, presented at the meeting, includes an article by Dr Tony Smith on progress in cancers of childhood, with special reference to work supported by the ICRF. "In the long run," he says, "the psychological care of the patient and his family may prove to be just as important as the right combination of drugs"; and a research project at St Bartholomew's Hospital is looking at the impact of leukaemia and its problems on families and on the children themselves, both the survivors and those who died. After the death of a baby

"As parents of a stillborn child or one that has died after birth you may feel very alone." This is the starting point of *The Loss of Your Baby*, produced by the Health Education Council in conjunction with MIND and the National Stillbirth Study Group. Emphasising that mourning is both natural and necessary and that the mother should discuss her feelings, the booklet gives advice on sources of support and also on practical matters. Instructions to authors

The following are the minimum requirements for manuscripts submitted for publication.

A stamped addressed envelope or an international reply coupon *must* accompany the manuscript if acknowledgment of its receipt is desired.

(1) **Typing** should be on one side of the paper, with double or triple spacing between the lines and 5-cm margins at the top and left-hand side of the sheet.

(2) **Two copies** (or preferably three) should be submitted.

(3) **Spelling** should conform to that of *Chambers Twentieth Century Dictionary*.

(4) **References** must be set out in the style used in the *BMJ*, and their accuracy verified before the manuscript is submitted.

(5) **SI units** are used for scientific measurements. In the text they should be followed by traditional units in parentheses. In tables and illustrations values are given only in SI units, but a conversion factor must be supplied. For general guidance on the International System of Units, and some useful conversion factors, see *The SI for the Health Professions* (WHO, 1977).

(6) **Authors** should give their names and initials, their current appointments, and not more than two degrees or diplomas. Each author must sign the covering letter as evidence of consent to publication.

(7) **Letters to the Editor** submitted for publication must be signed personally by all the authors.

(8) **Acknowledgments** will *not* be sent unless a stamped addressed envelope or an international reply coupon is enclosed.

(9) **Detailed instructions** are given in the *BMJ* dated 6 January 1979 (p 6).
