Professor Rogers is to be congratulated on his achievement in a field in which his own investigations have played such an important part.

## CASEWORKER AND CLIENT

The Caseworker's Use of Relationships. By Margaret L. Ferard and Noel K. Hunnybun. Foreword by John Bowlby, M.A., M.D. (Pp. 133+xi. 20s.) London: Tavistock Publications. Springfield, Illinois: Charles C. Thomas. 1962

The authors of this small book are British social case-workers of long experience, one formerly senior tutor at the Tavistock Clinic. They discuss psycho-analytical concepts which they have found of value in their work. They realize that their particular approach to clients and their problems may not appeal to every caseworker; as they point out, it is a disciplined approach, requiring study and thought and a true assimilation of the psychological concept on which it is based if it is to be used effectively. These psychological concepts are set out in the early part of the book; subsequent chapters deal with "meeting the client" and "the helping process."

The authors stress the importance of being a good and observant listener, so as to be able to build up, from what is observed or what is said, some impressions of his past that may help to explain the client's present attitudes and behaviour; they find it is often helpful to have such questions in mind as, "What is it that the client is really wanting?" "Is the problem that he is describing the sole reason for his coming?" These will strike a chord familiar to the family doctor, and he, too, will share the authors' experience that situations sometimes present themselves which leave the professional man or woman with a deep sense of humility over his inability to help.

### MEDICINAL CHEMISTRY

Progress in Medicinal Chemistry. Volume 2. Edited by G. P. Ellis, B.Sc., Ph.D., F.R.I.C., and G. B. West, B.Pharm., D.Sc., Ph.D. (Pp. 201+ix; illustrated. 60s.) London: Butterworths. 1962.

In 1933 the curriculum for students of pharmacy in the United Kingdom was enlarged to include pharmacology. The change came at an appropriate time, when the introduction of new drugs was showing clear signs of acceleration, and when the need for chemists in pharmaceutical industry to learn something of drug action was pressing. The results have been considerable. The departments of pharmacology in medical schools have for the most part remained small, but the addition of departments of pharmacology to all schools of pharmacy has conspicuously aided the development of pharmacological research in this country.

The book under review is one of the results of the change described. It is the second volume of a series intended for the student pharmacist and for the chemist in pharmaceutical industry. It is an advanced work, and demands stern application from those who read it. There are five sections, of which the first will be extremely useful not only to pharmacists but to all who are interested in the patenting of drugs. The section gives a full account of the patent laws not only in this country but also in the U.S.A., France, and Germany. This section alone makes the book useful for reference.

For the rest, there are sections on the development of drugs for relieving pain, on drugs for neuromuscular blockade, on anaphylactic reactions, and on those antiadrenaline substances the halogen alkylamines. Of these the best is the section on neuromuscular blockade by Dr. W. C. Bowman, which is well illustrated, clear, and interesting.
