## POPULATION STUDIES AND RHEUMATISM

The Epidemiology of Chronic Rheumatism. Edited by J. H. Kellgren, M. R. Jeffrey, and J. Ball. Volume I. (Pp. 356+xix; illustrated. 60s.) Volume II. (Pp. 44+x; illustrated. 25s.) Oxford: Blackwell Scientific Publications. 1963.

This is a report of a symposium organized by the Council for International Organizations of Medical Sciences on population studies in relation to chronic rheumatic diseases. It was held in Rome in 1961 under the chairmanship of Professor J. H. Kellgren. The aims were to review the available data from field surveys; to discuss the techniques; to consider the contribution of such surveys; and to formulate plans for future work. Physicians from many European countries, the United States, Australasia, South America, and Japan took part.

The inadequacy of the statistics currently available was generally recognized, and it was emphasized that mortality rates were of little help in chronic diseases such as rheumatoid arthritis.

Contributors from many countries underlined the difficulties of carrying out field surveys and stressed the importance of advance publicity in order to achieve a high completion rate. It was emphasized that clinic experience afforded little reliable information, and much praise was given to the excellent studies reported from the Empire Rheumatism Council's Field Survey Unit based on Manchester University.

An Italian report showed the importance of congenital joint deformities, particularly those that involved the hip, as precursors of degenerative joint disease. It was felt by many that a genetic factor was of significance in the aetiology of osteoarthrosis, but there was disagreement on the part that occupation played in its development. A high incidence of gout in Filipinos was reported.

It became clear that population surveys provided evidence of a disease's prevalence but did not give information as to its severity. Only careful clinical follow-up could elucidate the natural history. It was stressed that in future surveys titres of agglutination tests and degrees of radiological change should be recorded.

There is invaluable material for the rheumatologist in the first volume, which should be available for reference in every department seriously studying the rheumatic diseases. Excellent notes on diagnostic criteria and different agglutination tests are provided. The second volume is an atlas of standard radiographs of different types of arthritis, with clear-cut grading which will be of great value for future surveys and collaborative studies.

As the chairman of the symposium said in his summing up, the growing pains of methodology have now been left behind, and this publication marks a notable step forward in the study of rheumatic disease.
