and freshness, ignoring the repetitive pot-boilers and yet recognizing those papers presenting a really original contribution. If this could be combined with a critical commentary, a book of considerable value would emerge. One flinches at the thought of the work involved—and where does one find the necessary superman?

The editors of this collection make no attempt to fulfithese qualifications since it is not their allotted task. Yet within the framework of their assignment they are extremely competent. Though a number of the articles summarized seem pointless, quite a few are valuable, and these are usually printed in full with many illustrations. The scope is wide, including head and neck surgery and a section on hare-lip and cleft palate in which few laryngologists in Great Britain would be interested. A quarter of the book is concerned with audiology, which illustrates the growing importance of this aspect of the specialty. The book is very good value for money, and its compact size and clear print make it easy as well as virtuous armchair reading.

## PSORIASIS IN THE FAROES

Psoriasis. Prevalence, Spontaneous Course, and Genetics. A Census Study on the Prevalence of Skin Diseases on the Faroe Islands. By Gunnar Lomholt. (Pp. 295; illustrated.) Copenhagen: G. E. C. Gad. 1963.

This significant and valuable contribution to dermatology by the distinguished son of the late Svend Lomholt, of Copenhagen, records a unique survey of skin diseases in an isolated community. The study was conducted on the Faroe Islands over the course of a year, from 1947 to 1948, and was limited to the total population of the North and East Islands. Interest centred particularly round the prevalence of psoriasis, its genetic features, natural history, and spontaneous course.

The survey disclosed 312 cases of psoriasis in a population of 10,984. The prevalence was the same in males and females, and in blondes and brunettes. The median for the age of onset was 12 or 13 years. Interesting findings were the low incidence of psoriatic arthritis and the absence of diabetes in any psoriatic patients. There was a high incidence of lesions on face and hands—25 to 30% of the patients.

Much attention was paid to genetic factors; all pedigrees are included in an appendix. The high rate of consanguinity —5.1% first-cousin marriages and 25.4% matings of more remote relatives—did not seem to be of notable importance in the occurrence of psoriasis. Some eugenic guidance as to the likelihood of the condition arising in offspring is given from the experience of this survey.

Dr. Lomholt includes a short review of the prevalence of other skin diseases. These were studied less exhaustively. It is valuable to have a careful survey of this type, even though it does no more than confirm previous clinical observations.
