

were it not for the rather stiff price. In most undergraduate curricula, apart from those of adequate honours courses, the lectures and practical classes are enough to stimulate interest and create a picture, but insufficient to supply any deep or wide understanding of the biology of bacteria. Chemistry, physiology, biochemistry, physics, genetics, taxonomy, and other disciplines are adequately treated in their own right in other textbooks and monographs. Here they are shown as part of the scientific study of bacteria as bacteria. The exercise is well done, with good examples, adequate references, insight, and imagination. This is not a book for the elementary student or for the worker whose interest is essentially the applications of bacteriology within his particular sphere. Rather it is a book for the graduate who desires to study bacteria as bacteria with a reasonable background of general science but necessarily without deep knowledge of all the disciplines used in bacteriology. The result is a book that will help the reader to become

a better bacteriologist and to gain a good insight into scientific method in general.

Progress in Age Research

Biological Mechanisms of Aging. By Howard J. Curtis. (Pp. 133 + xii; illustrated. \$6.50.) Springfield, Illinois: Charles C. Thomas. 1966.

Dr. Curtis's lecture is a review of the cytogenetic and mutational theories of aging processes; his own thinking has now moved from simple mutation. It is a hazard of such reviews that they are overtaken by experiment, and mutation in somatic cells is already giving place as a subject for age studies to free-radical and cross-linking effects, and to the behaviour and stability of lysosomes. This, accordingly, is a brisk and comprehensive discussion of the progress of age research

as it was a couple of years ago. The author, who has himself done much to promote its obsolescence, will certainly not regret that he has been beaten to the post by the advance of the subject. The condensation necessary in a shortish lecture does, however, lead to some confusion between the discussion of actual mutation of single genes, which now seems an unlikely cause of age deterioration, and other forms of chromosomal damage. Since one of the author's own chief contributions to age theory has been the recognition of the importance of repair processes and of chromosomal stability in the determining of normal and of post-irradiation lifespans, the difference is a critical one, and the non-cytogeneticist reader risks missing the direction in which gerontological thinking is developing. These considerations apart, however, Dr. Curtis has provided an excellent introduction to the type of problem now concerning gerontologists.
