


stringency to alter this policy as this would be to the detriment of their main function, which is to ensure that they can act quickly when they find the opportunity to create change and development." Nevertheless, the trustees allocated £2 million to long-term research of this kind. Another £1 million was used to finance research fellowships.

The report is pessimistic about the outlook for fundamental research, pointing out that when funds are short projects with potential immediate practical value tend to be given higher priority than "those centres of the highest quality which, due to their originality, are so in advance of their time."

The Burroughs Wellcome Fund, a North American non-profit foundation, announced last week that it had endowed the first chair in clinical pharmacology in the United States at the Johns Hopkins University School of Medicine.


New Professors at Guy's

Dr. M. H. Lessof has been appointed to the chair of medicine tenable at Guy's Hospital Medical School. Dr. Lessof, who is 46, received his medical education at King's College, Cambridge, and Guy's Hospital, London, graduating in 1947 and becoming M.R.C.P. London in 1949. He has worked at the rheumatism unit of the Canadian Red Cross Memorial Hospital, Taplow, the Johns Hopkins



Hospital, Baltimore, and Guy's Hospital, London, where he was appointed clinical immunologist in 1967 and physician with charge of the endocrine department in 1969. Dr. Lessof obtained his M.D. in 1956 and was elected F.R.C.P. in 1969. His main research interests are concerned with methods of modifying allergic and immune reactions, and he is associate editor of *Conybeare's Textbook of Medicine*.

Mr. Ian McColl has been appointed to the chair of surgery tenable at Guy's Hospital Medical School. Mr. McColl, aged 38, graduated M.B., B.S. London in 1957. He became F.R.C.S. England, and F.R.C.S. Edinburgh in 1962, and M.S. London in 1966. After house appointments at Guy's and a junior lectureship in the departments of anatomy and physiology he became junior registrar at St. Bartholomew's Hospital and later resident surgical officer at Putney Hospital, as well as working part-time at the Hospital for Sick Children and St. Mark's and St. Peter's Hospitals. He returned to Guy's where he was senior registrar, 1962-4, and then lec-



turer on the surgical unit. With the Moynihan fellowship of the Association of Surgeons of Great Britain and Ireland, he went to Harvard Medical School in 1967, the year he was appointed reader in surgery at St. Bartholomew's Hospital Medical College. He became sub-dean of the medical college in 1969. Mr. McColl's interests include gastrointestinal endoscopy, preoperative psychological assessment of patients undergoing peptic ulcer surgery, and the pharmacology of intestinal absorption. He is honorary secretary of the British Society of Gastroenterology.

Darling Medal for Achievements in Malaria

The Darling Foundation Committee of the World Health Organization, on the advice of the Expert Committee on Malaria, has recommended to the executive board of W.H.O. that the twelfth Darling medal and prize should be awarded jointly *ex aequo* to Professor L. J. Bruce-Chwatt, director of the Ross Institute, London School of Hygiene and Tropical Medicine, and to Professor Augusto Coradetti of the Istituto Superiore di Sanità, Rome, for their outstanding achievements in the field of study and control of malaria. The presentation of the awards will take place at the World Health Assembly in Geneva this month.
