Social Security Abuse

Problems of medical certification receive attention in the Government's Report of the Committee on Abuse of Social Security Benefits, London, H.M.S.O., Cmnd. 5228, price £1.65. The committee, chaired by Sir Henry Fisher, stated that it did not intend to examine the standards of certification applied by family doctors or to pass judgement on them, but it had taken considered evidence from the B.M.A. and the General Medical Services Committee. Among the conclusions reached by the committee were that where long-term certification is concerned few difficulties arise; that while introduction of self-certification for claims of up to seven days might be an effective means of relieving general practitioners of routine work and making them freer to examine on behalf of the Regional Medical Service, it would certainly encourage fraudulent claims; and that patients should be more readily referred to the Regional Medical Service despite doctors' fear that this will repercuss unfavourably on their practice size and doctor-patient relationships. Patients' requests for convenience-dating of certificates is deprecated, and the period of a certificate's validity should, in the view of the committee, be related to the doctor's ability to predict the duration of the incapacity. Overall, it does not appear from the report that abuse of benefits by fraudulent medical certification is a major finding.

Medical Art Society

The 30th Exhibition of the society was opened by Professor Carel Weight, R.A., at the Leighton House Art Gallery, London.
