### Regulation of the Profession

In the leading article "Regulation of the Profession" (16 June, p. 627) the quotation on specialist registration from the B.M.A.'s draft evidence to the Merrison Inquiry should have read as follows:

"So far as the content of the registers is concerned, the simple fact of qualification as a medical practitioner is all that needs to be registered, on the assumption that specialist registration comes into being in the United Kingdom upon implementation of the Medical Directives. We therefore propose that the registration of higher qualifications be discontinued, though a distinguishing mark indicating a practitioner's specialty might usefully be added, where appropriate. If, however, specialist registration does not come into being in the United Kingdom, then a comprehensive list of higher qualifications would probably be essential."

It was reported incorrectly that this section of the evidence had been amended. It was approved in its original form.

It was also reported incorrectly that the Meeting had "disagreed with the idea that deans should have the duty of certifying every student at qualification as mentally and physically fit to practise," when, in fact, the Representative Body had agreed with the proposal. We regret these errors.
