society—the aged, the disabled, the physically and mentally handicapped, the sick, the socially inadequate, poor families, children in trouble-all can be better served by a new partnership between voluntary organisations and the Government." He hoped the consultative document, Priorities in Health and Personal Social Services, would be "a vital part of an expanding dialogue with voluntary bodies." He also said that the Government would reserve the right to look carefully at the way the grants were spent to ensure that the Government got good value for the taxpayers' money.

Fluoridation

The DHSS has issued a circular (HC(76)34) commending fluoridation of water supplies to health authorities, in the light of the recent report from the Royal College of Physicians, Fluoride, Teeth and Health. Half a million pounds of DHSS money is being earmarked in each of the financial years 1976-9 to help meet the capital cost of setting up fluoridation schemes.

Careers in medicine

A practical handbook on the requirements and facilities for postgraduate training in the main specialties has been produced by the Council for Postgraduate Medical Education in England and Wales. Intended for final year medical students and recently qualified doctors, the book gives sketches of the characteristics of work in different specialties, some comment on the intensity of the competition for posts and the prospect for late entrants and women, and specific details of a training programme in cases where it has been agreed by the appropriate joint committee. The range extends from the individual medical and surgical specialties to Voluntary Service Overseas and aviation medicine. Careers in Medicine is priced £2.00 (+20p postage) and may be obtained from postgraduate deans or from the council, 7 Marylebone Road, Park Crescent, London NW1 5HA.

Planning in Scotland

A network of multidisciplinary planning advisory groups has been set up by the Scottish Health Service Planning Council in order that its strategies might take account of factors such as housing, education, and employment. While warning that the network will not of itself ensure progress, the council says in its annual report (HMSO, Edinburgh, 45p) that the advisory structure has already put forward important recommendations. In particular, on the basis of advice received the council is recommending fluoridation of the public water supply.

European Travelling Fellowships

The Commission of the European Communities, advised by the Committee on Medical Research and Public Health, is sponsoring European Travelling Fellowships for physicians, medical researchers, or public health officers who are actively engaged in public health or population studies. Successful applicants will spend two weeks to three months in

an institute of epidemiological research within the EEC outside their own country. The commission will pay travel and hotel expenses and will expect a report of the visits within one month of return home.

Applications may be sent either directly to the Commission of the European Communities, Directorate-General Research, Science and Education, XII/C-1, 200 rue de la Loi, 1049 Brussels; or, for applicants from Britain, to the Medical Research Council, 20 Park Crescent, London W1N 4AL.

Final selection may be made by interview. Applications, by 31 August, should be accompanied by a curriculum vitae and an outline of the proposed programme, including the centre applicants wish to visit.
