## Training for occupational medicine

"Doctors in industry today must have much more than clinical expertise; understanding of management and union organisation and, above all, anticipation of health hazards and their control are essential," said Dr Peter Taylor, vice-dean of the Faculty of Occupational Medicine of the Royal College of Physicians, commenting on the work of the faculty during its first year. Six hundred and fifty doctors have so far been admitted to the faculty, which was established last year to act as a professional standard-setting body. Proposals for minimum standards of training and experience for doctors who work in industry are being formulated by the faculty and a discussion document has already been circulated to all members. Final proposals, expected in the next year, are likely to specify a minimum training period under the guidance of an accredited specialist and also an examination. Dr Taylor also spoke of the ethical problems that may arise for a doctor practising in industry: for example, he or she must preserve the professional code and at the same time avoid being seen as either "a tool of management" or "in the pocket of the unions." The faculty is now formulating guidelines for its members. It can also make a valuable contribution, said Dr Taylor, as an authority on occupational medicine. During its first year it has submitted evidence on occupational asthma and prescribed diseases to the Industrial Injuries Council and has given evidence to the DHSS on occupational health services in the NHS.

### Health Service Commissioner: annual report for 1978-9

In 1978-9, 712 complaints were received by the Ombudsman, compared with 584 in 1977-8 and 493 in 1974-5. Of the 712 complaints last year, 574 were rejected as being outside his jurisdiction, chiefly because they concerned clinical judgment; and over half were found to be unjustified (compared with 36% the previous year). ### Drugs withdrawn

preparations Antihistamine containing methapyrilene are being withdrawn from sale in Britain on the advice of the Committee on Safety of Medicines, following reports in the United States that the drug causes hepatic tumours in rats. The products concerned are Co-Pyronil capsules, Histadyl EC syrup, and Vortel capsules and syrup.

## New professors, University of London

Dr Malpas, who is 47, graduated in medicine from London in 1955, and after house appointments at St Bartholomew's Hospital served as an RAF medical officer from 1957 to 1960. After appointments at the Royal Postgraduate Medical School and St Bartholomew's Hospital, in 1962 he became lecturer in medicine in the Nuffield department of medicine, Oxford. In 1965 Dr Malpas was appointed registrar and later senior registrar at St Bartholomew's Hospital; he was senior lecturer in medicine there from 1968 to 1973, when he was appointed to his present post of director of the Imperial Cancer Research Fund department of medical oncology at St Bartholomew's Hospital.

### Road Traffic (Seat Belts) Bill

## Instructions to authors

The following are the minimum requirements for manuscripts submitted for publication.

A stamped addressed envelope or an international reply coupon must accompany the manuscript if acknowledgment of its receipt is desired.

(1) Typing should be on one side of the paper, with double or triple spacing between the lines and 5-cm margins at the top and left-hand side of the sheet.

(2) Two copies (or preferably three) should be submitted.

(3) Spelling should conform to that of Chambers Twentieth Century Dictionary.

(4) References must be set out in the style used in the BMJ, and their accuracy verified before the manuscript is submitted.

(5) SI units are used for scientific measurements. In the text they should be followed by traditional units in parentheses. In tables and illustrations values are given only in SI units, but a conversion factor must be supplied. For general guidance on the International System of Units, and some useful conversion factors, see The SI for the Health Professions (WHO, 1977).

(6) Authors should give their names and initials, their current appointments, and not more than two degrees or diplomas. Each author must sign the covering letter as evidence of consent to publication.

(7) Letters to the Editor submitted for publication must be signed personally by all the authors.

(8) Acknowledgments will not be sent unless a stamped addressed envelope or an international reply coupon is enclosed.

(9) Detailed instructions are given in the BMJ dated 6 January 1979 (p 6).
