due to staff who have left the authority's employment should be notified to the staff; where their current address is in doubt they should be asked to confirm it, so that payment can be made. There have been two amendments to the terms and conditions of service. A consultation fee at the standard rate will be paid for each domiciliary consultation if a dcctor sees more than one case at the same residence on the same occasion provided that the cases are clinically unrelated. Another ar endment provides for allowances to be paid te clinical and senior clinical medical officers fcr port health work. For general practitioners implementation is authorised in Health Notice HN(FP)(80)18, which describes the action to be taken to make payments on account if necessary. Payments on account should be made at the end of June if payments of arrears cannot be made by then. The notice also includes revised allowances for additional motor vehicles under the trainee practitioner scheme. The criteria for eligibility for seniority payments has been altered and the statement of fees and allowances includes the following new paragraph: "The eligibility for a seniority payment of a practitioner on the Medical List at 31 March 1980 will continue to be determined in accordance with the criteria in force immediately prior to 1 April 1980 until it becomes more favourable to the practitioner for eligibility to be assessed in accordance with the [revised] criteria set out . . .?

Clinical academic staff: salary increases

The Clinical Academic Staff Salaries Committee, chaired by Lord Hunter of Newington, met on 3 June and considered a draft implementation letter for salary increases for clinical academic staff following the recommendations in the Review Body's *Tenth Report* for NHS doctors. The draft was published on 9 June. The agreed salary scales, payable from 1 April, will be published in a future issue.

Prescription "season tickets"

From 1 December the charges for prepayment certificates (season tickets) will be $\pounds 15.00$ for an annual certificate and $\pounds 5.50$ for a four-monthly certificate. At present the certificates are worth while for anyone requiring more than 17 prescription items in a year or more than six items in four months. At the new prices, they will be worth while for anyone requiring more than 15 items in a year or five items in four months. Certificates at the current rates of $\pounds 12.00$ a year and $\pounds 4.50$ for four months may continue to be purchased before 1 December and will remain valid for their full period.

Instructions to authors

The following are the minimum requirements for manuscripts submitted for publication.

A stamped addressed envelope or an international reply coupon *must* accompany the manuscript if acknowledgment of its receipt is desired.

(1) **Typing** should be on one side of the paper, with double or triple spacing between the lines and 5-cm margins at the top and left-hand side of the sheet.

(2) Two copies (or preferably three) should be submitted.

(3) **Spelling** should conform to that of Chambers Twentieth Century Dictionary.

(4) References must be in the Vancouver style $(BM\mathcal{J}, 24$ February 1979, p 532) and their accuracy checked before submission.

(5) SI units are used for scientific measurements. In the text they should be followed by traditional units in parentheses. In tables and illustrations values are given only in SI units, but a conversion factor must be supplied. For general guidance on the International System of Units, and some useful conversion factors, see The SI for the Health Professions (WHO, 1977).

(6) Authors should give their names and initials, their current appointments, and not more than two degrees or diplomas. Each author must sign the covering letter as evidence of consent to publication.

(7) Letters to the Editor submitted for publication must be signed personally by all the authors.

(8) Acknowledgments will *not* be sent unless a stamped addressed envelope or an international reply coupon is enclosed.

(9) Detailed instructions are given in the BMf dated 5 January 1980 (p 6).
