

interesting to learn that the antibiotic-antimitotic drug mithramycin may be of considerable value.

Chapters 20 and 21 (the chapters are numbered consecutively from the start of Volume I) are on electrolytes and water metabolism and renal disease. Treatment for these conditions is far more effective than in the past and it is clearly presented. Nevertheless, haemodialysis and renal transplantation are dealt with rather too briefly, even for a student's textbook. No figures are given for duration of survival after these measures. The risk to personnel in haemodialysis units and the organization of international collaboration in transplantation of kidneys might have been mentioned. The treatment of disorders of metabolism, including diabetes and vitamin deficiency, is on well-established lines. The final chapter on acute poisoning indicates the value of non-specific resuscitative therapy and the help that may be obtained from the various poisons information centres.

In all, this is a practical, well balanced, up to date, and readable volume.

About Bone

The Physiology of Bone. Janet M. Vaughan. (Pp. 325; 50s.) Clarendon Press. 1970.

This book on the physiology of bone is the work of a single author, and as such it must be reckoned an impressive achievement. There are about 900 references (with titles) to previous work in it—apart altogether from a subject and an author index and a detailed table of contents. The last three make the book easy to use.

The term physiology of bone has been taken to embrace a considerable amount of anatomical and chemical structure, and at least a third of the book is devoted to this. Some of the microscope photographs and autoradiographs illustrating this part of the book are excellent. The exchanges of calcium, magnesium, and phosphorus between the plasma and the intestine and the movement of ions into and out of the skeleton are also considered before we reach a discussion of the role of the skeleton in maintaining mineral homeostasis and an account of the hormones, vitamins, and minerals involved in this. The last chapter deals with a number of the enzymes found in bone and cartilage.

This book is unquestionably a good one and will probably become a "must" to anyone interested in bone, whether he be a student or an investigator. It is not, however, an easy book to read. Many of the words and phrases are highly specialized,

and a considerable amount of background knowledge is required to get the most out of it. At the same time it is sometimes disappointing to look up some tit-bit suggested by the index or the table of contents only to find references rather than considered opinions. It may be that a single mind can no longer cover a subject as large as this in a personal way, and that one should not regard the book as a student's textbook or an investigator's work of reference, but as an inspiration to them both to fill up the gaps in their knowledge by further reading.

Duncan's "Metabolism"

Diseases of Metabolism. 6th edition. Genetics and Metabolism, Endocrinology and Nutrition. Ed. Philip K. Bondy, M.D. (Pp. 1413; illustrated.) Two volumes; sets 331s. 6d. single volumes 178s. 6d. London: W. B. Saunders. 1969.

The editorship, authorship, format, and content of this classic text have all been changed; only the title remains inviolate. The new "Duncan" is a child of its time, fathered by men who have grown up in the era of scientific medicine and at a time of great expansion in biochemistry. Their writings are a tribute not only to themselves but to an intellectual environment which has enabled them to produce such a satisfactory clinical and scientific amalgam in their work.

Volume 1 covers genetics and metabolism. Though the clinical and biochemical aspects are interspersed and well integrated throughout the book, the early chapters, which deal specifically with fundamental genetics and intermediary metabolism, will provide a useful reference work in their own right. This section is followed by excellent chapters on disorder of carbohydrate metabolism, lipid metabolism, sphingolipidoses, the amino acid disorders, purine and pyrimidine metabolism, porphyrias and porphyrias, disorders of bilirubin metabolism, and connective tissue disorders. A great deal of detailed information has been condensed into these well-written and in some cases extensively illustrated chapters.

Volume 2 is a text book of endocrinology with also a section on nutrition. The endocrine glands including the gonads are covered in a series of chapters dealing with their physiological, biochemical, and clinical aspects. There are also chapters on neuro-endocrine interrelations, aldosterone, water metabolism and the neurohypophysis, and on acid base balance. The section on nutrition is relatively short and deals with malnutrition, obesity, vitamins and the metabolism of the trace metals, copper, zinc, and manganese. Each chapter is followed by long lists of references. The authors have

been given the opportunity of bringing their contributions up to date in a series of addenda which are published at the end of each volume and this is a useful innovation.

This sixth edition of Duncan's *Diseases of Metabolism* can be recommended as a comprehensive reference text for clinicians and for laboratory workers who are concerned with human metabolic and endocrine problems.

"Doctors in Law"

The Doctor and the Law. J. Leahy Taylor. (Pp. 176; 40s.) Pitman. 1970.

Legal aid, the National Health Service, and the liability of hospitals for possible negligence by their staff have resulted in increased litigation of doctors and a heightened consciousness in the profession of its legal responsibilities. Leahy Taylor's book is particularly apposite in this respect, dealing comprehensively with the pitfalls that may beset the doctor with an authority based on experience and wisdom distilled after years of counselling in the medical secretariat of the Medical Protection Society.

The book covers the whole field of medical protection from possible mishaps affecting fledgling students to the murky depths of professional misconduct. The doctor's relationship and standing to police and solicitors is put in a novel and correct perspective, as are all matters pertaining to appearances in courts and other aspects of criminal law in relation to medicine. The practitioner faced with an allegation of assault, defamation, or negligence never deals with the matter satisfactorily without immediate advice from his medical defence organization, and often, if this is not obtained, his ignorance, anxiety, and panic allow him to commit errors greater than that of which he has been suspected or accused. In this context case reports from the Medical Protection Society vividly illustrate doctors' dilemmas. The author's lively literary style prevents such medical matters being dealt with in a dull, prosaic, or monotonous fashion.

Though the book mainly concerns the newly qualified younger doctor it will undoubtedly appeal to medical men of all ages. It is not only instructive but highly readable and entertaining. The practitioner may put it on his bedside table at the end of a busy day with a wry but thoughtful smile for some of his less fortunate colleagues' activities and misdemeanors. "Doctors in Law" would be an equally good title for this excellent book, which is a really valuable addition to a forensic library.
