Chair of Child Health

Professor R. G. Mitchell, Professor of Child Health at Aberdeen, has been appointed to the chair of child health at the University of Dundee in succession to Professor J. L. Henderson, who retires in September.

Professor Mitchell graduated from Edinburgh University in 1944 and proceeded M.D. in 1953; he is a Fellow of the Royal College of Physicians of Edinburgh. After graduation he held several hospital posts in Edinburgh, Liverpool, and London, and from 1952 to 1955 was a lecturer in child health in the University of St. Andrews, spending a year as Rockefeller Travelling Fellow in Physiology at the Mayo Clinic. From 1955 to 1963 he was consultant paediatrician to the Dundee Teaching Hospitals and was appointed to the chair of child health at Aberdeen in 1963. Professor Mitchell is a member of the Advisory Committee on Medical Research, the Scottish Advisory Council on Social Work, chairman of the Aberdeen Association of Social Service, and chairman of Aberdeen and Children's Panel Advisory Kincardine Service.

Testing for Australia Antigen

Regional transfusion centres should begin at the earliest possible date to test all blood donations for the presence of Australia antigen and its antibody, according to a report issued last week. Staff in these centres should be tested initially as a condition of appointment and afterwards voluntarily, and those found to be antigen-positive should not assist in the preparation by an open process of blood or blood products destined for clinical use. A donor found to be positive for antigen or antibody should not be allowed to continue as a donor of blood for clinical use, and he should be invited to give permission for his general practitioner to be informed. These are some of the recommendations of the National Health Service Revised Report of the Advisory Group on Testing for the Presence of Australia Hepatitis Associated Antigen and its Antibody, 1972.

Health Service in 1971

The average daily number of available hospital beds in England continued to decline in 1971 from the earlier years' totals. There were 4,000 fewer than in 1970. The average duration of stay in hospital also decreased, though the number of patients treated rose in both medical and surgical divisions. The number of psychiatric and geriatric day patients again increased.

Facilities for general practitioners' postgraduate education continued to expand during the 1970-1 academic year. During the year 16,195 doctors attended grant-aided courses in England. The trend towards group practice continued, so that now well over half of the general practitioners are in groups. Over half of all local health authorities' staff (nurses, health visitors, and midwives) are now attached to practices .-Department of Health and Social Security, Annual Report 1971 (London, H.M.S.O., £2.85 net).
