# Design Council Awards for Medical Equipment

The Design Council together with King Edward's Hospital Fund and the Department of Health and Social Security is to give awards for good design in the British medical equipment industry. The first awards will be announced in May 1975 and they will be given annually for products which show outstanding achievement in the design of medical equipment used in diagnosis, therapy, or rehabilitation. Products will be assessed in three main categories: medical scientific equipment (including mechanical, electrical, electronic, hydraulic, and pneumatic apparatus); biomedical equipment and appliances (to include implant devices, aids for the disabled, patient-handling equipment, etc.); and surgical equipment, instruments, and related equipment (including equipment hospitals, for services in operating theatres, and for use by nursing staff). All products must have been designed and made in Britain, although a product embodying foreign components will not be excluded.

Judging will be by a panel of eight, among whom is Professor M. K. Sykes, Royal Postgraduate Medical School.

## Coping with Disablement

Some of the difficulties and how to overcome them for the disabled and the elderly whose increasing limitations change their way of life are described in a paperback from the Consumers' Association. Many kinds of physical aids to the handicapped are ennumerated and the addresses where they can be obtained are given. Apart from well-known devices used in the nursing context many special aids to cooking and laundering exist, and some hints on how to continue to be independent in these and allied matters without mechanization are included under the headings of "kitchen," "bathroom," and so on. There is a section on getting out, including minimizing the problems of air travel, and the book ends with a list of voluntary organizations and notes on what they set out to do. ## Health of Women

A Family Doctor booklet on women's health has recently been published. While women live longer than men, the booklet states, they have a number of special health problems many of which are comparatively minor and easy to rectify. Anaemia, cystitis, bowel problems, anxiety, and the gynae-cological gamut of symptoms and disease are among those discussed in straightforward terms by Dr. Wendy Greengross in 25 pages. #### **Darling Foundation Prize**

Dr. Ian Alexander McGregor and Dr. Amar Prasad Ray have been awarded the Darling foundation medal and prize—given for outstanding work on malaria—by the World Health Organization at its 27th assembly.

Dr. McGregor is head of the laboratory for tropical community studies at the National Institute for Medical Research, London, and has been a member of the W.H.O. expert advisory panel on malaria since 1960.

Dr. Ray is also a member of the W.H.O. expert advisory panel on malaria and since 1973 has been director of the malaria research unit at the School of Public Health and Tropical Medicine, University of Sydney, Australia.

The European Organisation for Research on Treatment of Cancer has recently introduced clinical training Fellowships in medical oncology.
