


**Professor of Experimental Pathology,
Manchester**

Dr. W. L. Ford, senior lecturer in the department of pathology, Edinburgh University, has been appointed to a chair of experimental pathology in the department of



pathology at Manchester University, from 1 January 1975. Dr. Ford, who is 37, graduated in medicine at Edinburgh in 1960 and in physiology at Oxford in 1962. Subsequently he has held appointments as lecturer in the department of therapeutics,

Edinburgh, as a member of the scientific staff of the M.R.C. at its cellular immunology unit at the Sir William Dunn School of Pathology, Oxford, and at the Institute for Experimental Immunology, Copenhagen University, where he held a Royal Society European travelling fellowship.

Cancer Research Campaign Chair of Medicine

Professor P. K. Bondy, C.N.H. Long professor of medicine, Yale University, since 1966, has been appointed to the Cancer Research Campaign chair of medicine at the Institute of Cancer Research, Royal Cancer Hospital, London. Professor Bondy has been a professor of medicine at Yale since 1961 and since 1972 he has been the Cancer Research Campaign visiting professor of medicine and head of the then newly created division of medicine at the Royal Marsden Hospital and the Institute of Cancer Research. Professor of General Practice at Guy's

Dr. P. M. Higgins, senior lecturer in general practice in the University of London at Guy's Hospital Medical School since 1968, has been appointed to the newly established Bernard Sunley chair of general practice at Guy's. Dr. Higgins, who is 51, graduated M.B., B.S. London, in 1947. He went into general practice in a mining area in the Midlands in 1953, moving to Birmingham in 1966 to establish a group practice on a new estate, and again in 1968 to establish the Guy's teaching practice at Thamesmead, in south-east London. He has been regional adviser in general practice for the South-east Thames Region since 1970.

Royal Society Awards

The Council for the Royal Society has announced the following appointments from 1 October 1974.

Dr. G. B. Warren, M.R.C. junior research fellow at the National Institute for Medical Research, has been awarded a Stothert research fellowship to work on the reconstruction of specific membrane functions from pure protein and defined lipid components, at the department of pharmacology, Cambridge.

J. Sainsbury research fellowships have been awarded to Dr. M. W. J. Davie,

registrar in medicine at Addenbrooke's Hospital, Cambridge, to continue work on the development and application of a calcium binding protein assay in man, and to Dr. P. J. Garlick, research officer in the department of human nutrition, London School of Hygiene and Tropical Medicine, to work on the response of protein metabolism in vivo to dietary and hormonal stimuli.

The Florey Fellowships Committee of the Australian National University has appointed Dr. R. N. McBurney, senior research officer at the school of physiology and pharmacology, University of New South Wales, to the second Florey fellowship. He will work at the physiology laboratory, Cambridge, for two years, on the physiology of excitable cells.

Additions to the British Pharmacopoeia 1973

Three new monographs for analgesics which may be obtained without prescriptions have been introduced by the British Pharmacopoeia Commission, and become effective on 1 September 1974. The monographs are on aspirin and codeine tablets; soluble aspirin and codeine tablets; and aspirin and caffeine tablets. All of these are in addition to analgesic monographs already published in the *B.P. 1973* and *B.P.C. 1973* and are not intended to replace those containing phenacetin, though restrictions on phenacetin come into operation on the same date (see *B.M.J.*, 8 June, p. 569).
