## Guidance for Social Workers

The British Association of Social Workers has published a code of practice for those social workers and their supervisors concerned with the care of children at risk of assault by their parents. The recommendations, which appeared in *B.A.S.W. News* of 4 September, are part of a longer report from a working party from the child and family care section of the B.A.S.W., which will be published in full later in the year.

The code stresses the high priority that should be given to cases where a child may be at risk; when an incident of possible child assault is reported a visit must be made that day by the social worker concerned. In cases of absence, the person receiving the report should make sure that the supervisor is told about it so that immediate action can be taken. Ultimately it is the supervisor's responsibility to ensure that any child alleged to be ill-treated is visited on the day the allegation is made, the code continues. It recommends that medical examination should be arranged at once unless there is substantial evidence that the injury was sustained accidentally.

The code also emphasizes the importance of multidisciplinary teamwork and the need for social workers to be aware of the scope of the specialist knowledge of other professionals.

Commenting on the detailed recommendations, the *B.A.S.W. News* says that "the standards will seem high, almost impossibly so, to many conscientious, overworked social workers trying to cope with excessively large work loads. . . . The code of practice can be used by social workers to put pressure on their employers to provide the staff, money, training, and resources necessary to achieve this level of practice."

## Deutsche Medizinische Wochenschrift

This month sees the 100th anniversary of the publication of the first issue of the *Deutsche medizinische Wochenschrift*, now the most widely read weekly medical journal in the German language. The *D.M.W.* has satellite editions in other languages—Greek, Italian, and Spanish—and its original articles have summaries in English, German, and Spanish.

Among fundamental papers published in the *D.M.W.* have been contributions by Koch, Wassermann's description of his serological test for syphilis, and Reiter's account of his syndrome; we have no doubt that these high standards will be maintained into the 21st century.

### Surgery of Male Sexual Disorders

We regret that the table to show organic causes of impotence mentioned in Mr. Pryor's article (6 September, p. 586) was omitted. We give it below:

Congenital:	absence of fibrosis of corpora cavernosa
Traumatic:	spinal cord injury, fractured pelvis, surgical (abdominal perineal resection, sympathectomy, cystectomy)
Vascular:	priapism, arteriosclerosis (Leriche syndrome)
Neurological:	spinal cord lesions, peripheral neuropathy
Endocrine:	diabetes, hypogonadism
Pharmacological:	parasympathetic blockade, sympathetic blockade.
