in getting suitable placements for such children, and imply deficiences in the health and educational services in this respect.

It is unfortunate that Dr. Agatha Bowley's chapter on assessment is so short, since adequate psychological appraisal of such children is the kernel of the matter. Nearly half of the 157 children labelled as the "abnormal group" are shown as "untestable," which is worrying since most children, however disturbed, can be given some sort of provisional assessment of their objective performance on some observational scale or other. The table of results of psychological testing merely shows "I.Q." and does not indicate chronological or mental age, so that it is difficult to see how far the claim that "subnormality" is responsible for failure of communication is justified, especially when 15 children with an I.Q. above 70 are included as subnormal. The authors point out that these children had considerable emotional overlay, but it is then pertinent to ask why they did not put them in their category of "subnormal and emotional disturbance."

The tradition that the pencillium floated in through a window and settled on a grown culture of staphylococci is shown to be almost certainly fallacious; a remarkable series of chances must have conspired to produce the effect Fleming observed.

Professor Hare worked at Queen Charlotte's at the time the sulphonamides were introduced for the treatment of puerperal sepsis, and in Toronto at a time when the Connaught Laboratory had to undertake large scale production of penicillin. He tells of these and other experiences with verve, spice, and darts. This is a readable and revealing book.
