will recognize that a number of sections have reappeared virtually unaltered. This is not an adverse criticism of a book designed to teach the fundamentals of blood group serology. The important basic principles have changed little over the last few years, though research in this field is advancing at an ever-increasing rate. Some sections have been expanded and new ones added. New information has been provided on the automation of blood grouping, the assay of factor VIII, intrauterine transfusion, the administration of therapeutic anti-D immunoglobulin, serum fractionation, and on most of the blood-group systems including serum allotypes. The application of blood groups to forensic medicine is particularly well discussed, one of the authors being a leading expert in this field.

Some errors present in the previous edition have been taken on into the new one. One end paper, illustrating stages in the production of ABH and Lewis blood group substances, contains a statement that O_h Le (a-b-) individuals are rare whereas O_h Le (a+) persons are extremely rare. The frequencies of these two phenotypes should be interchanged.

Advanced readers who need detailed information on recent discoveries will need to look eslewhere to supplement what is provided here, but those working in a routine laboratory will find that it meets almost all their needs.

have written histories which partially cover the ground, Dr. W. D. Foster of King's College Hospital, London, who spent four years as a professor in Kampala, has produced a most readable and inexpensive paperback history, which will not only add to his established reputation as a medical historian but will remind us of the great part played by the missionaries of the C.M.S. in opening up Africa, of the vital influence of a handful of R.A.M.C. officersnotably Bruce-and of the remarkable tale of Aldo Castellani (still with us), of the trypanosome, and of sleeping sickness. The early beneficence of Henry Wellcome is recorded.

This valuable study indicates the whereabouts of source material still to be quarried.

Social Aspects of Child Care

Foster Care: Theory and Practice. V. George. (Pp. 251; 60s.) Routledge & Kegan Paul. 1970.

The author, who is a lecturer in applied social science at Nottingham University, writes not only as a research worker in various aspects of child care, but also from wide experience in the field. Finding the literature on foster care in this country to be still very scanty he set out to discover the prevailing relationship between theory and practice. His investigations were concentrated on three local authorities, two urban and one rural, which he calls Largetown, Smalltown, and County. His report, which includes a large number of statistical tables, provides the most complete and objective study yet available of British theory and practice relating to the fostering of children in public care.

The book is divided into four main sections, starting with a historical review of the principles and issues of foster care in the 19th and early 20th centuries. The second and third sections deal with present concepts and actualities regarding the role, recruitment, and assessment of foster parents, and the placement and supervision of foster children. The final section analyses the outcome of the cases studied, offering conclusions and recommendations.

While paying tribute to the efforts of field workers and the considerable advances in understanding of the problems of deprived children and the greatly improved training of staff, the author notes that there is still a wide gap between theory and practice, mainly owing to the urgency of taking into care, and the shortage of suitable foster homes. Two-thirds of the children admitted are under 5 years and, despite the wellknown disadvantages of placement of such young deprived children in families with their own children of similar age and sex, such "dumplings" are still frequent. Three-fifths of the children received have siblings, but families are still broken up and the author was disturbed to find that even trained and experienced child care officers did not always ensure that the separate members knew where their siblings were from the outset. or subsequently make suitable arrangements for keeping them in touch with each other. He was particularly concerned to find that less use was made in 1968 of expert psychiatric and psychological advice than in 1961.

The whole book reflects the author's objective but understanding approach, and although it requires close reading, it merits careful study by all who are concerned with social aspects of child care. A useful reading list is provided, but many of the essential footnote references are not dated. This is a disadvantage which should be remedied in any future edition.
