# Splints and Braces

Orthopaedic Appliances. Brian H. Day, F.R.C.S. (Pp. 140; £1.45 paper cover, £2.95 cloth cover) Faber & Faber. 1972

Mr. Day has produced a book which is undoubtedly of value as an introduction to the neglected field of orthopaedic appliances; in 140 pages he has collected together, illustrated, and described a useful but limited selection of the devices available to treat some of the commoner orthopaedic conditions conservatively. However, the book suffers from a tendency to uncertainty of purpose in that despite the author's premise in the preface that the diagnosis in each circum-

stance has been decided and that reference is made only to the clinical features relevant to the choice of appliance, he veers at several points into discussion—for instance, on complications resulting from the mismanagement of hand injuries and on the conservative treatment of minor foot conditions. While this is perhaps difficult to avoid, the result is uneven, and the latter part of the book lacks the incisiveness and point of the first sections on cervical collars, corsets, and braces.

On several further points the author must be taken to task. Why does he include a section on abduction splints of the upper

limbs, which have an extremely limited application and are, on his own admission, difficult to fit and unsatisfactory in use, and omit completely any reference to Thomastype calipers and bucket-top calipers for the later management of lower limb injuries and knee instability? No reference is made, either, to such important devices as the Milwaukee brace, which, although controversial, is in orthopaedic use regularly in many countries. Finally, the use of plastics in orthotic practice is referred to only in the briefest of terms and the newer foam plastics are ignored altogether.

# Cytodiagnosis

The Cytologic Diagnosis of Cancer. 3rd edn. Ruth M. Graham. (Pp. 476; £8·30.) W. B. Saunders. 1972.

In the preface to this book the author says that it is intended as a guide to cellular interpretation; as such it is liberally illustrated with photomicrographs and explanatory line drawings. The cellular morphology of all regions lending themselves to cytodiagnosis are described, with new chapters added since the last edition on the changes associated with oral contraceptives and the cytology of aspirates from the pouch of Douglas. The latter deals primarily with the early diagnosis of ovarian cancer and demon-

strates the use of cytology in this particularly difficult field of medicine. Tumours of the ovary pose considerable problems in histological interpretation, especially in the assessment of epithelial tumours of borderline malignancy. To overcome the additional diagnostic hazards attendant on the use of cytological methods alone obviously demands wide experience based on unlimited clinical material. For this reason one wonders whether such accuracy is not beyond the reach of the majority of routine laboratories.

Much cytological information can be derived from the detailed descriptions and illustrations in this book, and the exhaustive bibliography provides an excellent guide to additional reading. The author rightly

stresses the importance of close clinical cooperation and the necessity for complementary surgical biopsy. However, the inadequate correlative histological illustrations do not facilitate interpretation of the text. Certain inaccuracies can be found, particularly in the ovarian sections; for example, granulosa cell tumours and luteomas are not, as the author states, germ cell tumours, and pseudomyxoma peritonei is not in itself an ovarian tumour but a possible complication of such a neoplasm. Such statements regrettably detract from the merits of a book based on vast experience and meticulous attention to cytological detail.

# Information for the Hospital Administrator

Hospital Information Systems. Ed George A. Bekey, and Morton D. Schwartz. (Pp. 402; \$19.75.) Marcel Dekker. 1972.

Government publications on the Reorganised National Health Service are now coming at us thick and fast. They are loaded with talk about management, accountability, cost effectiveness, cost benefit, planning, and priorities, but unless the new area and district management teams are provided with much fuller and more reliable information than is available at present about the health needs of the populations they are to serve and about the cost, distribution, efficiency, and effectiveness of the health services they are to manage, all the ta'k will prove to have been so much hot air. Good health information systems are essential to the planning and organization of rational health services—to the definition of health care priorities and the allocation of available resources (money, manpower, and machinery) in relation to those priorities

and to local needs and existing local services. Without such systems the new specialists in community medicine will be unable to perform effectively their key roles at regional, area, and district levels.

Information about hospital activities is, of course, only part of the story, but it is a most important part because a most costly part of it. Hospital Information Systems, a book of 400 pages, puts between hard covers a series a papers which have been given at summer courses held at the University of Southern California since 1969. It provides a factual and well-documented acount of the attempts being made in the United States, and particularly in Southern California, to handle the vast quantities of data now generated by hospitals and to relate them to the problem of the alarming and continuing increase in the costs of hospital care, the increasing complexity of hospital management, and the elusive and difficult matter of measuring the quality of medical care. (The even more elusive and

difficult matter of measuring the relative benefits of different methods of medical care is hardly mentioned.) American medical and administrative jargon is in many small ways different from our own, but the differences are no barrier to understanding the message. Patient "billing" looms, but not too large. Both "hardware" and "software" aspects are discussed, and among the many datagenerating areas covered are the hotel-like activities of hospitals (inventory, control of personnel, supplies, beds, meal orders, etc.), diagnostic laboratories, therapeutic activities (particularly prescribing), intensive care units, and coronary care units.

The book contains much of interest to our own hospital administrators, biomedical engineers, and medical computer experts. And although it is focused on the American scene and limited to hospital services, it can be recommended to the members of our new area and district management teams.
