E.B.S.

The King's Fund has issued its 36th annual report on the Emergency Bed Service for the year ended 31 March 1974. According to the report, 5,000 fewer applications were made to the E.B.S. than in the previous year, possibly because there was no serious outbreak of influenza in the winter concerned. One of the shortcomings of the service mentioned is that as many as one in six patients required the use of the medical referee to secure admission. The report is critical of the time wasted in admission being refused by a number of hospitals, with acceptance finally made at the hospital of first inquiry through invoking the services of the medical referee. Better record keeping in the hospital admissions office is recommended to help reduce these problems.

Despite the reorganization of the N.H.S. and the new four regional health authorities for London, the E.B.S. anticipates that its service will continue in the present form for the foreseeable future. Consultation Techniques

A grant of £38,000 has been awarded by the Leverhulme Trust to Professor J. Knox (department of general practice), Mr. A. Morrison (department of education), and Mr. D. Alexander (department of audiovisual aids), all of the University of Dundee, for a three-year study on medical interviewing. The award is to be used to form a team of clinician, social scientist, film technician, and secretary, which will work with doctors in hospital and in practice to study different techniques in medical interviewing. Doctors' opinions will be sounded and simulated interviews conducted in an effort to produce an audiovisual teaching proon interviewing for gramme medical students.

Advisory Commission on Alcoholism

The Minister of State at the Department of Health and Social Security, Dr. David Owen, is to set up a committee to advise the Secretary of State on Services connected with alcoholism. Professor Neil Kessel has agreed to be chairman, and the members will be selected on the basis of recommendations from the professional health services, local government authorities, and appropriate voluntary bodies. The committee will be set up for an experimental period of three years in the first instance, and one of its stated functions is "to appoint a subgroup especially charged with promoting the development of services for homeless alcoholics."

Swedish Research Scholarships

The Swedish National Association against Heart and Chest Diseases is to award three research scholarships tenable for one year in Sweden. Each is for 25,000 Swedish Crowns (approximately £2,350) and the scholarships are open to non-Swedish cardiologists and chest physicians.

Applicants should produce evidence of ability in research in cardiovascular or lung diseases, and should propose a particular problem which they would like to study in Sweden. Ability to speak and understand Swedish, English, French, or German is essential.

The World Health Organization is to assist in selecting candidates, and application forms (WHO 379) are available only from W.H.O. Headquarters: Office of Science and Technology, World Health Organization, Avenue Appia, 1211 Geneva-27, Switzerland. The forms must be received by W.H.O. Headquarters in Geneva before 28 February 1975.
