

ing cough notifications had declined from 85,000 in 1957 to 2,400 last year and over the same period the number of deaths had dropped from 87 to two. Such figures illustrated the value of the immunization programme and the work that the joint committee was doing, he said.

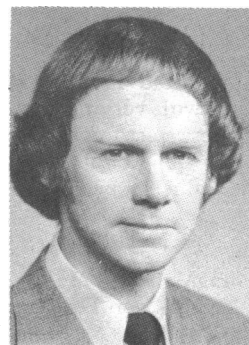
While a vaccination programme of any kind was carried out for the common benefit of society its primary purpose was to protect individuals, he said, and the fact that there was risk involved made it no different from many other medical procedures. The implications of compensation for the ill effects of vaccination where there was no question of negligence were very wide in the medical field, he said, and it was by no means easy either to decide whether disability was due to a particular procedure or what the right level of compensation for different disabilities should be. The view of successive Governments had been that the grant of compensation payments in those cases was not possible.

Mr. Morris stressed the deep concern and sympathy felt for the children who were unfortunate victims of vaccine damage and for their parents and said that action had not been limited to expressions of sympathy. Much had happened in recent years to alter the ways of looking at problems of that kind, he said, and the whole question was under review by the Royal Commission on Compensation and Civil Liability.

MEDICAL NEWS

Chair of Clinical Pharmacology, Manchester

Dr. George E. Mawer, senior lecturer in pharmacology, Manchester University, and honorary consultant physician, Manchester



Royal Infirmary, has been promoted to the chair of clinical pharmacology at Manchester. Dr. Mawer, who is 40, was educated at Blackpool Grammar School and at Edinburgh University, where he graduated in pharmacology in 1958 and in medicine in 1960.

Between 1961 and 1966 he worked in the departments of pharmacology and of therapeutics at Edinburgh. He then joined the department of pharmacology at Manchester and formed strong links with the department of medicine and other clinical units in the Manchester Royal Infirmary. Dr. Mawer's research has been mainly concerned with the handling of drugs in patients with kidney and liver disease, and the development of practical aids to calculate safe and effective doses for individual patients.

British Petition for Soviet Doctor

Nine hundred medical practitioners in Britain have signed a petition expressing concern at the fate of Dr. Mikhail Shtern of

Vinnitsa, in the Ukraine. Dr. Shtern, a well-known endocrinologist, was arrested in May this year and according to reports had been held without access to his family or to legal representation. It was not clear whether the charge against him is medical or political.

The letter of petition has been presented to the Soviet Embassy in London by Conscience, the Inter-Denominational Committee for Soviet Jewry.

Portugal and Cholera

The Department of Health and Social Security has been informed by the World Health Organization that Portugal has declared itself free of cholera from 28 November. Advice to travellers from the United Kingdom to Portugal (*B.M.J.*, 25 May, p. 453) therefore no longer applies.
