

SIR,—I am directed by the Committee to transmit you the enclosed copy of a memorial which has been forwarded for presentation to Sir George Grey, and to request you to insert it in the next number of your *Journal*.

"To the Right Honorable Sir George Grey, one of Her Majesty's Principal Secretaries of State.

"As Chairman of a Committee of members of the medical profession residing in Manchester and its neighbourhood, appointed at a public meeting to watch the progress of the Medical Reform question, I am directed respectfully to represent to you that a statement has appeared in the public journals to the effect that the Council of the Royal College of Surgeons of England are about to petition the Crown for the grant of a Charter that shall amend and rectify the anomalies and deficiencies of that conceded in 1843.

"The Manchester Committee having maturely considered this reported proceeding of the Council of the College in its bearing upon medical legislation would respectfully impress upon you the justice and expediency of withholding all recommendation to her Majesty in conformity with such petition, until the Fellows and Members at large have had the outlines of the proposed Charter submitted to them for examination and discussion.

"The Committee beg further to represent to you that the Charter of 1843 was granted without any such previous notification; that when published, after its concessions, a condemnation of its provisions, all but unanimous, came from the profession at large; and that this circumstance has constituted the great obstacle to all recent attempts at medical legislation.

"Finally, the Committee would express their conviction that the grant of a Charter to the College of Surgeons, which should bring the Institution into harmony with its members, who constitute the great majority of English practitioners, would remove all serious impediment to a satisfactory settlement of the question of Medical Reform.

# Medical Intelligence.

### THE SAMUEL COOPER TESTIMONIAL.

A general meeting of the subscribers, in furtherance of this object, was held on Wednesday, the 12th December, 1849, at the Thatched-house Tavern, in St. James-street; Colonel Wood, of Littleton, in the chair. The first resolution was moved by Mr. Erichsen. in a speech wherein a review was taken of the career of the late Professor Cooper, and a penegyric pronounced on his character, and terminating to the effect, "That a testimonial be established to record the esteem in which Professor Cooper was universally held for his honourable character and private worth; his distinguished acquirements and ability as a teacher; as well as for his invaluable services in the improvement and diffusion of surgical science." This was seconded by Mr. Chippendale, and unanimously carried. Dr. Wood then moved, and Mr. Baker, of Staines, seconded the motion, "That a marble bust of the late Professor Cooper be executed; and that, should the funds permit, reduced copies of the bust, in Parian, be presented to each subscriber of one guinea and upwards. The place of deposit of the original bust to be deferred until it is executed." (The latter clause, it afterwards transpired, was only introduced as a compromise at the last meeting of the committee, at which certain parties made their appearancefor the first time, to oppose the placing of the bust in the Royal College of Surgeons, which locality had been previously determined upon by the committee as the most honourable.) Dr. Sieveking then proposed that the following gentlemen be nominated as a committee to carry the objects into effect, viz., Mr. Cadge, Dr. Camps, Mr. Chippendale, Dr. Croft, Dr. John Hall Davis, Mr. Erichsen, Mr. Durancé George, Mr. Howell Morgan, Dr. Richard Quain, Dr. Storrar, Dr. C. J. B. Williams. Colonel Wood; the treasurer, Mr. Hillman; and the

secretaries, Dr. Wood and Mr. Wailes, ex officio. Seconded by Dr. Powell, and carried. Dr. C. J. B. Williams, who just then arrived, proposed "That it be an instruction to the Committee to bear in view the placing of the bust in the Royal College of Surgeons." This being violently opposed by Dr. Storrar, was withdrawn, and Dr. Croft proposed, and Dr. Richard Quain seconded, "That on the completion of the bust, a general meeting of the subscribers be convened to determine where the monument be placed:" carried. Dr. Richard Quain moved, and Mr. Caver seconded, "That the treasurer and secretaries be requested to continue their offices:" carried. The chairman having left the chair, this was taken by Dr. C. J. B. Williams, on the request of those present, when it was moved by Dr. Camps, and seconded by Mr. Howell Morgan, "That the best thanks of the meeting be presented to Colonel Wood, for his courteous, able, and impartial conduct in the chair:" carried. Colonel Wood having returned thanks, the meeting separated. At a meeting of the committee, it was determined that the execution of the bust be entrusted to Mr. Butler, sculptor, of Middlesex-place, New-road, and the treasurer and secretaries, together with Mr. Chippendale and Dr. Richard Quain, were requested to make the necessary arrangements.

### ACADEMY OF MEDICINE OF PARIS.

The Academy proceeded, on the 17th instant, to the election of office-bearers for the ensuing year. M. Bricheteau was elected president, and M. Orfila vice-president, and M. Gibert re-appointed annual secretary. Our readers are aware that M. Dubois (d'Amiens) is perpetual secretary.

## SURGEON-DRUGGISTS AND THE FELLOW-SHIP OF THE COLLEGE OF SURGEONS.

We are informed that among the members recently admitted Fellows of the Royal College of Surgeons, is one who keeps a druggist's shop. We understand that the Fellowship was established in order to create a higher grade of surgeons. Either the shop or the Fellowship should be put down.—Medical Gazette.

## HOMŒOPATHY AND THE CHOLERA.

In deference to the assertions and large claims of the advocates of homoeopathy, and in consideration of the comparatively small success obtained over the mortality of cholera by any method of treatment, the administration of the hospitals Salpétrière and St. Louis submitted a few cases to the homoeopathic mode of practice, but the result did not warrant its continuance. The physicians report that all the cases proved fatal.—
