PETITIONS TO PARLIAMENT FROM THE CENTRAL COUNCIL.

Petitions to both Houses of Parliament in favour of the claims of the Assistant-surgeons of the Navy, have been presented to the Lords by Lord Monteagle, and to the Commons by Sir H. Inglis. Petitions to both Houses of Parliament, embodying the resolutions of the Committee appointed to report on the evils resulting from the indiscriminate sale of arsenic, have also been presented from the Central Council.

ASSISTANT-SURGEONS OF THE ROYAL NAVY.

With indescribable feelings of satisfaction we record in this number of our journal the victory gained in the House of Commons, on Monday night last, by that hitherto persecuted portion of our profession, the Assistant-surgeons of the Royal Navy. At the same time, it is a source of bitter disappointment to us that we were prevented by indisposition from participating on the spot in the pleasures of the victory. for the relief of our injured friends declared, that the accommodation provided for them in Her Majesty's ships of war is insufficient for securing the full benefit of their professional services. Captain Boldero sustained his motion by a very effective statement of the grievances and annoyances to which the Assistant-

surgeons of the navy are constantly exposed, and, on a division, he obtained forty-eight votes against forty recorded for keeping the persecuted parties in the cockpit. Admiral Berkeley was as violent as ever against the motion, while Admiral Dundas, we understand, addressed the House in a tone which indicated that he was not perfectly hostile to the resolution which Captain Boldero had proposed.-Lancet.
