During the prevalence of cholera, the President has appointed the following Medical Council, to assist him by their advice: Dr. Paris, Sir James Clark, Dr. Alderson, Dr. Babington, Dr. Tweedie, Dr. Baly, Mr. Lawrence, Mr. Simon, Professor Owen, Mr. N. B. Ward, Mr. John Bacot, and Dr. Farr.

In addition to the above, a scientific committee has been appointed, consisting of members of the Council, and Dr. Sutherland, Dr. R. D. Thomson, Dr. Hassall, and J. Glaisher, Esq. The subjects which engage the attention of this committee are, meteorology, the question of water supply, the chemical analysis of the atmosphere and of the water from the different companies, the investigation of the pathology of the disease, etc.

The present Board has been appointed for a term of twelve months; but the whole subject is to be brought before Parliament, with the view of placing the Board of Health on a permanent footing. It is to be hoped that through no political or other changes the country will lose the benefit it expects to derive from the appointment of Sir Benjamin Hall as Minister of Health. He has proved himself to possess a thorough knowledge of business, together with the energy and judgment which is required in one holding so difficult and trying a position. The President of the Board of Health will, we hope, receive from the members of the medical profession that cordial support to which he is justly entitled. The appointments which he has made give evidence of the value which he attaches to professional services, and of his desire to become acquainted with the opinions of the profession respecting the great sanitary questions now engrossing the attention of the country. The homceopathic and Julie-mesmeric vagaries imputed to Sir Benjamin Hall are, we trust, either stupid calumnies, or transgressions against common sense which have been repented of, and may now be forgiven.
