FROM DR. CORMACK TO THE MEMBERS OF THE ASSOCIATION.

Gentlemen,—I had intended to have addressed you at some length on parting, but I forbear, as I can no longer through these pages speak to you honestly and from my heart, without the risk of being charged with dishonourable conduct. I cannot, however, break the last link by which we are united without saying to you that this separation is to me most painful. Under great difficulties I served you. Through my official connexion with the Association, I have gained many attached and valued friends, from whom I have received tokens of encouragement and regard, for which I am sincerely grateful, and which I shall never cease to cherish. Under these circumstances, then, I cannot but acknowledge and record that to me our separation is not less painful than it is imperative.

The following letter, which I have addressed to the Executive Council, will sufficiently explain to you the circumstances under which my connexion with you is brought to a close a week before the date fixed for the appointment of my successor.

"37 Russell Square, 26th September, 1855.

"Gentlemen,—On Thursday, the 20th current, Sir Charles Hastings called upon me; and we had some conversation regarding the publication of communications in which the affairs of the Association were discussed. I stated that the JOURNAL of next day had gone to press, and that it contained letters from Dr. Cowan, Mr. Parker, and others. It was clearly understood by Sir Charles that the number was at press, and that it was to go forth exactly as it had been made up by me.

"Sir Charles Hastings offered to relieve me at once—from that day—from all editorial responsibility, by himself attending to the Journal till my successor's entrance upon his duties: and at last it was mutually agreed that during my occupancy no communications connected with the affairs of the Association were to appear till they had been examined and approved by Dr. Williams. I have not had it in my power to infringe this agreement entered into with Sir Charles Hastings, inasmuch as no number of the JOURNAL has appeared since it was entered into. I therefore conceive that a letter which I received from Sir Charles Hastings on Monday, the 24th, and which I enclose [Enclosure No. 1], is a letter which it is better not to reply to; and further, I feel that, as this letter is written by your President in his official capacity, I am obliged at once to surrender the residue of my editorial powers into your hands.

"On the part of Dr. Hall, there has been—I say not with evil intent—a suppressio veri. I at first declined to print any letters on the York meeting: but I afterwards wrote to Dr. Hall and others, stating that their letters would, if they chose, be printed. The views entertained by the writers did not influence me in the slightest degree. I now repeat what I said in the JOURNAL of last week—'that I have not since the meeting at York suppressed one line which has been sent for publication from members holding sentiments opposed to my own; while I have only acknowledged privately nearly two hundred letters upon the York meeting and its results, because they were chiefly occupied with expressions of kindness towards myself.'

"I have by this post, in accordance with my agreement with Sir Charles Hastings, sent all the communications upon Association affairs which I have received for publication, to Dr. Williams of Worcester; and the following is a list of them.

"To prevent any irregularity in the publication, I have supplied the printer with materials, which, even without the Association documents, will be more than sufficient for the Jeurnal of the 5th October. This week's number is already nearly prepared; and in it I mean to insert this letter as the most concise explanation which I can give of my declining to allow my name to appear after this week as the editor of a work over which I have ceased to have control.

*Dear Sir,—After my interview with you last week, I had hoped not again to have had occasion to address you on the subject of the Journal; but I cannot avoid expressing my surprise that you should publish two vehement letters from Dr. Cowan on your side, whilst it appears from Dr. Radelyffe Hall's letter to this week's Lancet you refused admission to a very temperate letter from him on the other side.

"I think the Executive Council may very likely notice this, especially as it is in direct contradiction to what you state in the Association Journal in your remarks on my letter; for you there say you have not suppressed one line which has been sent for publication from members holding sentiments opposed to your own.

"I shall be glad if you can explain this to me at your early convenience, and I hope you will bear in mind that I consider your honour pledged to me not to publish any other letter in the JOURNAL on Association affairs without first sending it to Dr. Williams.

"I shall be sorry indeed at the last to have any altercation; but it is my duty, as President of the Council, to see that the JOURNAL is not used for party purposes.

"SIR,—The accompanying letter was sent for publication to the Association Journal, and was rejected by Dr. Cormack on the ground of his not wishing 'to fill the Journal with squabbling letters'. As I did not intend it to come under that class, and do not think it does, will you have the goodness to publish it for me in the Lancet? "Your obedient servant,

" To the Editor of the Association Journal.

"SIR,—From the discussion at York on the propriety of changing the name of the Association, a dispassionate reader will conclude that there is 'a good deal to be said on both sides'. Might not the feelings of both parties be met by simply dropping the word 'Provincial', styling the Association merely 'The Medical and Surgical Association'?—thus retaining all the original name, excepting the first word, now no longer quite so applicable as at first. As a matter of taste and feeling, I, for one, have a strong prejudice in favour of not radically altering the name, whilst I can see some small advantage—although not nearly so much as its sanguine advocates advance—in ceasing to be styled par excellence 'Provincial'.

"It seems to be taken for granted by some that a certain feeling of jealousy exists against the Londoners on the part of the Provincial medical men. This, I am quite sure, is an error. We all respect the respectable, admire the eminent, and take a pride in the justly-celebrated of our profession, wherever they may happen to reside. And of these we all know that the very highest, and by far the largest number

will ever be, in the nature of things, resident in the Metropolis. In London, we know that the very best and very worst specimens of our own, and of every other profession, are to be found. But just as we may not admire all the policy of the College of Physicians or College of Surgeon, and yet may justly esteem the individuals who sit at the governing boards. so whilst we cannot feel a particle of jealousy towards the men, we do feel very considerable jealousy lest the Metro. politan Branch of the Association, possessing the editor of the JOURNAL and as much metropolitan centralisation-energy as it can muster on its side, should usurp more than a Branch's fair share of the government of the Association at large. That jealousy is very extensively felt; and no other. On the contrary, every additional name in our list of the eminent Londoners occasions a feeling of pleasure and of something akin to pride. We desire more of them, and less of Branch domination. Are such men to be coaxed to us by our changing our name! I think they are more likely to be attracted by the sight of a large public gathering once a year of old fellowstudents, conducting their meeting with kindness, courtesy, and pleasantness, affording to each other it may be, some little to instruct, and a good deal to interest, and leaving each a gainer possibly in knowledge, and certainly in friendliness. I can remember such meetings, without going farther back for an example than to the one at Brighton, or to that at Worcester. I have little doubt that the same expectation of a scene of confusion and excitement which deterred myself from wishing to attend this anniversary, even had it proved quite convenient, influenced many others also. The smallness of the muster at so central and accessible a place as York, may be taken as an omen of the future so long as our present civil war continues. In some way or other, an end must be put to our Annual Quarrel, or it requires no Daniel to foresee the consequence. We shall split up into a series of Branch societies, without a common bond of union, and without publications; consequently, without unity of purpose or public weight.
