MARCH 29, 1856.

"That it is well known that the legally qualified practitioners of this country are liable to a heavy penalty if found guilty of ignorance or mistake in their practice, yet the uneducated and staught charlatan is allowed to exercise his nefarious arts unmolested.

"That the examinations of candidates for the medical profession by the various Colleges and examining bodies granting diplomas, or licenses to practise, are not conducted upon one uniform standard, but differ widely from each other.

"That your petitioners believe that it will be for the good of the public if a law were passed to admit such persons only as had passed a standard of examination, founded upon one uniform course of instruction, to practise in medicine and surgery within Her Majesty's dominions, and to provide for a registra-tion of such qualified practitioners.

"That your petitioners believe that the said Bill is calculated to accomplish these and other important ends.

"Your petitioners, therefore, humbly pray that the said Bill may pass into a law. "And your petitioners will ever pray", etc.

The petition having been read and unanimously approved of, it was resolved that it be presented in the usual way, and that both the members for the borough and the county should be requested to support its prayer.

MEETING OF MEDICAL OFFICERS OF THE DULVERTON UNION.

## MEETING OF MEDICAL OFFICERS OF THE RYE UNION.

At a meeting of the medical officers of the Rye Union, held at the George Hotel, Rye, Sussex, on March 19th, the follow-

2. That the medical officers of this union do form themselves into a Local Committee, for the furtherance of this object.

3. That Mr. R. C. N. Davies be appointed Local Secretary; and a subscription of 5s. per quarter each, or any further sum that may be necessary, be paid him, to defray the expenses.

4. That this meeting consider that the sum of 15s. per case should be paid for ordinary cases of midwifery, under two miles; £1 per case over. The extra fees for midwifery to remain as they are.

5. That the following list of operations, not mentioned in the Consolidated Order, be paid extra : viz., trephining, setting lower jaw, clavicle, pelvis and ribs, ligature of arteries, ampu-tation of breast, excision of testicle, tapping, "ascites and hydrocele", catheterism, lithotomy and hthotrity, operation for cataract and strabismus, operation for artificial anus, etc., reduction of hernia, excision of upper and lower jaw, and resection of joints.

6. That the following dislocations be paid extra for: viz., dislocation of lower jaw, patella, spine, and slavicle

7. That the meeting consider the union medical efficers should be under the supervision of a Medical Inspector.

8. That all cases occurring in the Union House, that would entitle medical officers out of the house to an extra fee, be allowed to the surgeon holding the appointment.

9. That a copy of these resolutions be forwarded to Mr. Griffin, and to each of the medical periodicals.

THE LATE REV. DR. WARNEFORD. The Rev. Vaughan Thomas, B.D., has written for private circulation a Memoir of the late Rev. Dr. Warneford. From this memoir it appears that Dr. Warneford's donations to the Queen's College and the Queen's Hospital, Birmingham, with the date of trust-deed and object of endowment, were as follows :--- " December 20, 1838, £1,000, to found prizes for essays by medical students; Janu-£1,000, to found prizes for essays by medical students; Janu-ary 13, 1842, £1,000, salary of chaplain of the Queen's Hos-pital; June 6, 1844, £1,750, to found four scholarships in me-dicine; October 16, 1844, £1,000, salary of warden, as chaplain; April 14, 1845, £1,000, salary of warden, as lecturer: Sep-tember 19, 1846, £1,000, salary of Medical Tutor; August 21, 1849, £3,000, salary of Professor of Pastoral Divinity; January 00, 1061, 61,000, colory of medical warden. May 10, 1851 30, 1851, £1,000, salary of resident warden; May 19, 1851, £900, increased salary of warden; April 16, 1851, £1,400, increased salary of Professor of Pastoral Theology; April 15, 1852, £2,500, increased salary of ditto; April 15, 1852, £1,000, to found four theological scholarships; April 15, 1852, £6,500, increase of salary of warden; October 15, 1852, £2,000, salaries of professors of classical literature, of arts, and science. In addition to all these sums, Dr. Warneford gave £1,000 towards the building fund of the hospital; £500 towards the fever wards; and £200 towards fitting up the hospital chapel and dispensary; £500 towards the erection of the college chapel, consecrated by the bishop of the diocese; £1,000 towards furniture, etc.; £150 towards the purchase of books, models, etc.; and £500 towards the charter and supplemental chartermaking a total of £29,500."

EXECUTION OF THOMAS JONES. Thomas JONES, the murderer of Dr. Hope, the Convict Surgeon at Portsmouth, was executed at Winchester, on Saturday, March 22nd. Before he died, he repented of his crime, and acknowledged the justice of his sentence. It will be recollected that Jones was a convict on board the hulks at Portsmouth, and that he murdered Dr. Hope because he thought the latter treated him harshly on the trial. Several witnesses bore testimony to Dr. Hope's tenderness and humanity.
