

PROFESSOR OWEN. Lord John Russell, in moving a vote of £60,000 for expenses connected with the British Museum, on the 21st instant, referred in very flattering terms to the new appointment of Professor Owen. "A determination had been arrived at on the part of the trustees to appoint a Superintendent of Natural History; and it was understood a person whose name was known not in this country alone, but throughout Europe, would receive that appointment." Mr. Milnes, Mr. Disraeli, and several other speakers of opposite sides of the House, also spoke in terms of satisfaction at the appointment.

DOCTOR M'ILREE, who recently volunteered to go into Russia to attend to the health of General Williams, taken prisoner at Kars, has returned to Sebastopol. He states that General Williams is now residing near Moscow, having regained his health: Sir J. Hall recommends Dr. M'Ilree to the favourable notice of Lord Panmure, for this act of intrepidity and surgical valour, and for "undertaking a dangerous journey in winter across mountain passes," and through a Russian population adverse to his mission.

MEDICO-CHIRURGICAL SOCIETY. At the last meeting of this Society, a very interesting paper was communicated by Mr. Arnott from Mr. Sibley of the Middlesex Hospital, on the true nature of "colloid" growths and their relation to cancer. Some nine or ten cases were recited, where the disease had been found in the stomach or bowels, in the parotid, breast, etc. The experience of the Middlesex Hospital went to show that colloid is not so frequently associated with cancer as popularly believed; that there is no marked cachexia as in cancer; that it is a disease not essentially malignant, but completely *sui generis*; that it is found associated with tubercle; and that in some organs, as the liver, it occurs as "secondary" but not primary colloid.

"It may be in place to notice the increase of another scourge—insanity—of which the *Illustrated London News* of 17th February, 1855, says, 'In the City of London, without any increase of population, the number of lunatic poor has doubled within the memory of some of the guardians, and the cause has baffled their inquiries. Some are inclined to attribute this dreadful visitation to excess of eagerness and strife in commercial pursuits, or in mental exertions; others to diet, and some partially to the effects of railway travelling.' Why not to Vaccination?"
