



T.A.B. vaccine contains 1,000 million B. typhosus and 500 million each of B. paratyphosus A and B per cubic centimetre. Inoculation with this vaccine is strongly recommended for nursing staffs in fever hospitals and persons proceeding to infected areas anywhere (e.g., on holidays in many Continental countries), or to the tropics. Double inoculation (½ c.c. followed by 1 c.c. 7 to 10 days later) produces an immunity regarded as lasting about 12 months, at the end of which a further dose of 1 c.c. is advisable to maintain the immunity.

# VITAMIN THERAPY IN SUB-OPTIMAL NUTRITION

It is now a commonplace of modern dietetic knowledge that a diet liberal in quantity and apparently impeccable in quality is not necessarily a safeguard against many of the less dramatic manifestations of malnutrition.

Sub-optimal nutrition is known to be responsible for a variety of minor disorders which occur in the twilight zone of nutritive failure—for example, easy fatiguability, both mental and physical, functional digestive disorders with anorexia and gastro-intestinal atony, anæmia, emotional instability, neuritis, lowered metabolic rate, and many other manifestations which have often been grouped under the general term neurasthenia.

#### THE MOST ELUSIVE VITAMIN

It is now generally agreed that malnutrition is nearly always of a mixed pattern, and is seldom attributable to the lack of a single factor. Although under modern conditions in this country the end results of single gross vitamin deficiencies are seldom observed in medical practice, it should not be lightly assumed that no general vitamin deficiency may exist. It is more difficult, for example, to ensure an adequate intake of the vitamin B complex than of the other vitamins known to be important

in human nutrition. To maintain an optimal level of vitamin B<sub>1</sub>, the normal adult requires a daily intake of about 600 i.u., and to supply this from the ordinary food-stuffs even to-day may be a matter of considerable difficulty.

A deficiency of the vitamin B complex in the diet of the population generally is therefore more probable than that of other food factors, and there is a strong case for suspecting such a deficiency when considering the probable ætiological factors of many of the less spectacular conditions of ill-health.
