





# ANTI-STAPHYLOCOCCAL POWER of antiseptics

When blood is collected for transfusion—particularly if it is to be stored for a time—the paramount importance of avoiding skin contamination is plain. Yet the collecting needle must pass through skin known to harbour microorganisms in large numbers and the difficulty of rendering the skin sterile is an urgent and acute problem. The collection of blood and its subsequent culture can, therefore, be made a practical test of the value of an antiseptic in skin sterilisation. The following table sets out the comparative results obtained, using various procedures in parallel for the pre-operative treatment of the skin at the bend of the elbow of blood donors.

#### Comment on results obtained

Of the various procedures employed, only one yielded completely satisfactory results over a series of 50 tests—namely, O-syl Antiseptic in 5 per cent. aqueous solution.

The failure of other methods is marked unless spirit is added to the antiseptic solution, thus suggesting that the results obtained by these methods are due rather to the spirit content than to the antiseptic.

In fact, in the tests reported here, staphylococci proved to be the principal organism grown in 50 of the 56 cases (i.e. 89 per cent. of the positive cultures obtained) in which sterilisation of the skin appeared defective. As already reported in this journal, O-syl has been proved to be highly effective against staphylococci and it is undoubtedly this fact which leads to the results reported here. The failure of other procedures to give the desired result is due largely to their inability to kill staphylococci on and in the human skin.


