



- 2 BULLOUS IMPETIGO NEONATORUM. Benians and his co-workers (3) describe an epidemic of this condition due to staphylococci and suggest that statistics convey a suggestion that staphylococcal infections have become of greater frequency during the past two years.
- S STAPHYLOCOCCI IN THE NURSERY. Recent work has emphasised the importance of staphylococcus aureus in nursery infections in which they give rise to Breast abscesses in the Mothers and pemphigus in the Babies. There is, moreover, evidence that in some epidemics of conjunctivitis in the babies the condition is also due to the same organisms (4, 5, 6).
