New..and Overwhelming Evidence

STAPHYLOCOCCI are **COMMON PATHOGENS**

When this war began the importance of streptococci as infecting agents in man was both widely established and universally recognised.

But few medical practitioners acknowledged that staphylococci might be of equal importance.

To-day, despite the difficulties of keeping pace with advances in applied bacteriology in war time, there continues to accumulate incontrovertible evidence of the importance of staphylococci in the pathology of a number of conditions met with in medical practice.

'NEW FACTS ABOUT STAPHYLOCOCCI JUSTIFY THE INTRODUCTION OF A NEW ANTISEPTIC

Notes on the conditions referred to are given below: and it is suggested that these are a complete justification for the introduction of the new antiseptic, O-SYL. For, in order adequately to deal with these conditions, it is now appreciated that an antiseptic should be available which is capable of equal bactericidal activity against staphylococci as it is against streptococci.  1 IMPETIGO CONTAGIOSA. Bigger and Hodgson (1) have shown that 97% of their cultures yielded Staphylococci (mostly Staph, pyogenes) and only 32% streptococci (pyogenes). Moreover whilst staphylococci were present without straphylococci. In unopened vesicles all cultures yielded only staphylococci (aureus). Sheehan and Ferguson (2) during an independent survey agreed closely with these findings and in addition showed that impetigo was reproduced with similar frequency when human skin was inoculated with staphylococcus aureus as with fluid obtained from the lesions of spontaneous impetigo.

- 2 BUILLOUS IMPETIGO NEONATORUM. Benians and his co-workers (3) describe an epidemic of this condition due to staphylococci and suggest that statistics convey a suggestion that staphylococcal infections have become of greater frequency during the past two years.

 3 STAPHYLOCOCCI IN THE NURSERY. Recent work has emphasised the importance of staphylococcus aureus in nursery infections in which they give rise to Breast abscesses in the Mothers and pemphigus in the Babies. There is, moreover, evidence that in some epidemics of conjunctivitis in the babies the condition is also due to the same organisms (4, 5, 6).







Vitamin Therapy—Safeguarding the Invalid Diet

Present-day nutritional knowledge has emphasised that the provision of an adequate food intake for the invalid does not merely involve the provision of a light, bland, readily assimilable diet. 
