## *The Problem of the Common Cold*

The patient who habitually suffers from colds during the late autumn and early winter often constitutes an embarrassing problem in general practice.

The prophylactic use of an anti-catarhal vaccine is frequently of great help in such a case, and, in order that the patient's immunity may reach a maximum during the time of highest incidence of the cold, four injections (0.25 c.c., 0.5 c.c., 1 c.c. and 1 c.c.) of B.D.H.
