

Presentation :





The independent Royal Masonic Hospital has for 46 years provided facilities for admission and treatment of patients by its appointed medical staff of consultants. The Board, being aware that in London there are at present insufficient beds—in independent hospitals or as NHS pay-beds—to meet all demand, has recently implemented a significant increase in the beds available to would-be private patients.


After consultation with BUPA, and in agreement with the Medical Staff Committee, the Board has decided that, with effect from 1st October, 1980, the right to admit to these beds, subject to availability at the time, shall be extended to consultants not on the staff. This extension of admission (or to outpatient diagnostic facilities) is without regard to the relationship of either consultant user or patient user to Freemasonry.

In order to estimate demand and to plan the optimum use of this arrangement, application is now invited from holders (present or past) of established consultant posts at hospitals in Greater London who may wish to be allowed to avail themselves of the right to admit to (or to make use of diagnostic facilities at) the Royal Masonic Hospital.

In the course of its discussion with BUPA and PPP, the Board has obtained confirmation of the present shortage of beds and facilities in the London area. BUPA welcomes the opening of the Royal Masonic Hospital to consultants who may be asked to treat its subscribers, and hopes that this much needed facility will commend itself to consultant users.

British Council Medical Courses

THE CLINICAL MEDICINE OF OLD AGE

29 March-9 April 1981 in Cambridge

The chief aims of this course are first to describe the advantages in our knowledge of the scientific basis of clinical medicine in old age and secondly to discuss the resources needed for the provision of an effective geriatric service. The Directors of Studies will be Professor A N Exton-Smith, University College Hospital Medical School, London and Dr W Davison, Consultant Physician in Geriatric Medicine, Cambridge. The course is intended for senior physicians and psychiatrists with an interest in the problems of ageing.

HEARING SPEECH

31 May-12 June 1981 in London

The purpose of this course will be to provide an up-to-date review of the scientific bases relevant to hearing speech and particular practical considerations involved in the diagnosis and management of patients. There will be a series of lectures and demonstrations in laboratories and in clinics. Course members will be able to share their experience and knowledge in the appropriate sessions. Recent advances and potential developments will be reviewed and discussed. The course will be under the direction of Professor Adrian Fourcin, Department of Experimental Phonetics, University College, London, and Professor Ronald Hinchcliffe, Department of Audiological Medicine, Institute of Laryngology and Otology, London. The course is designed for senior clinicians and others concerned with the diagnosis and care of people with impaired hearing or speech.

INFLAMMATORY BOWEL DISEASE

29 March-8 April 1981 in Birmingham

The aim of this course is to review the current knowledge and practical management of inflammatory bowel disease, including ischaemic and pseudomembranous colitis. It will be held in The General Hospital, Birmingham. The Director of Studies will be Dr R N Allan of the Department of Medicine and Mr J Alexander-Williams of the Department of Surgery. The course will include the aetiology, the epidemiology of inflammatory bowel disease, the surveillance for and the prevention of cancer. Comparison will be made of the long-term results of medical and surgical treatment of Crohn's Disease and ulcerative colitis, including merits of the surgical options. Members of the course will be invited to contribute their views and experience. The programme will end in time to permit those interested to attend the Spring Meeting of the British Society of Gastro-enterologists which takes place in Bristol on 9-10 April 1981. The course is intended for physicians and surgeons with some years' experience in gastroenterology.

DIAGNOSTIC RADIOLOGY IN THE 1980s

22 March-3 April 1981 in London

The purpose of this course is to provide an up-to-date review of the various x-ray imaging techniques which have been formally established. An attempt will also be made to look into the future and to assess how these techniques fit in to diagnostic pathways in patient management. In addition to talks and panel discussions, members will be able to attend some clinical pathological conferences and clinical meetings where the importance of some of these new diagnostic imaging techniques will be evaluated in their true clinical setting, so that their importance to clinical decision making will become apparent. The courses will be arranged in two medical centres: at the Royal Postgraduate Medical School, Hammersmith Hospital, where it will be under the direction of Professor R E Steiner, and at St Bartholomew's Hospital, London, where it will be under the direction of Dr I Kelsey Fry. This course is designed for senior practising radiologists who are familiar and experienced in some of the newer methods of investigation.

ADVANCED PAEDODONTICS

8-20 March 1981 in London/Newcastle

The course aims to review current clinical practise, prevention of dental disease, teaching and certain aspects of research in the field of paediatric dentistry. The first part of the course will be undertaken in the University of London and a second component will be held in the University of Newcastle. It will be directed by Professor G B Winter, who is Head of the Department of Children's Dentistry at the Institute of Dental Surgery, one of the post-graduate institutes in the British Postgraduate Medical Federation of London University. The course is designed primarily for senior clinicians and academics involved in the practice of paediatric dentistry.

PAEDIATRIC NURSING

5-17 July 1981 in London

It is expected that some of the course participants will have knowledge and expertise of one or more of the subjects and will contribute to the discussions in the appropriate sessions. In fields where knowledge is expanding, recent advances and potential developments will be reviewed and discussed. The course will be under the direction of Miss B M Barchard (Chief Nursing Officer) and Miss D M Saunders (Principal Nursing Officer—Education). The course is designed for senior nurses involved in the clinical management and teaching aspects of paediatric nursing.


