





If vomiting persists the patient should be re-assessed to exclude the possibility of an underlying disorder, e.g. cerebral irritation.

Various extra-pyramidal reactions to Maxolon, usually of the dystonic type, have been reported. The incidence of these reactions in children and young adults may be increased if daily dosages higher than 0.5 mg/kg body weight are administered.

The majority of reactions occur within 36 hours of starting treatment and the effects usually disappear within 24 hours of withdrawal of the drug. Should treatment of a reaction be required, an anticholinergic anti-Parkinsonian drug, or a benzodiazepine may be used. Since extra-pyramidal symptoms may occur with both Maxolon and

phenothiazines, care should be exercised in the event of both drugs being prescribed concurrently.

Raised serum prolactin levels have been observed during metoclopramide therapy: this effect is similar to that noted with many other compounds.

Maxolon's action on the gastro-intestinal tract is antagonised by anticholinergics. Although animal tests in several mammalian species have shown no teratogenic effects, treatment with Maxolon

is not advised during the first trimester of pregnancy.

Following operations such as pyloroplasty or gut anastomosis Maxolon therapy should be withheld for three or four days since vigorous muscular contractions may not help healing.

Tenancy or licence agreements and an inventory of property should be issued for doctors occupying authority accommodations. This will ensure that the applicant has full details of the appointment before interview. Authorities have also been requested to organise visits for intending applicants, who are advised to satisfy themselves, preferably in writing with the details provided before attending an interview or accepting an appointment

Doctors applying for registrar and senior registrar grade posts are advised to ascertain the status of those posts for the purpose of higher professional training

Warning on contracts: The CCHMS has agreed with the DHSS a model form of contract to be issued to all consultants and associate specialists. Although the DHSS has recommended this model to all RHAs, in some instances individual regions have amended the model, thereby changing important clauses. The BMA advises members not to sign a contract if it deviates from the model contained in PM(79) 11 and if in any doubt suggests that they contact their BMA regional office

Criteria are laid down for determining the commencing salaries of consultants and any members who experience difficulty in this respect are advised to seek the advice of the secretary of the association

Consultants: According to DHSS circular HC(82)10, which deals with the appointment of consultants and senior registrars, doctors who are able to work only part time for personal reasons, such as domestic responsibilities, disability, or ill health, are entitled to apply for vacancies and advertised posts should be read as including this condition

Advertisements should state the number of notional half days offered for part time consultant appointment or, for whole time appointments, offer a maximum part time option. In the view of the BMA an advertiser should not insist on possession of an English higher qualification in preference to Scottish or Irish qualifications (or vice




