Some patients are more susceptible to vaginal candidosis than others



Candida cells are capable of penetrating to the depth of several layers of the vaginal epithelium This suggests that the hidden yeasts may be protected from topical antifungal agents, only re-emerge and prolifere again some time later when the epithelial cells are normally shed. The deeper layers of the vaginal mucosa are mo accessible by systemic than by topical route. Thus, in patients who appear highly susceptible to vaginal candidosis, oral Nizoral treatment makes good sense.




