TO PROFESSIONAL GENTLEMEN, INVALIDS, AND OTHERS.

In the first place, he is desirous to state that the transfer of the commercial business entirely to himself, has arisen solely from the profession and habits of the inventor indisposing him for vending occupations.

J. T. TYLER desires next to inform the profession, that the power of all three grades of the RESPIRATOR has been reduced; experience, which alone could be the guide, having established the fact, that each grade, of high, medium, and low power, was more warming than its purposes required. For the word "power" that of "temperature" has been substituted. The RESPIRATORS of high, medium, and low temperature, are calculated to correspond respectively with the climates of the south of France, Madeira, and the West Indies; that is, they will be found to raise the average winter air of England to the average winter air of those climates.

He begs next particularly to request attention to the proper adaptation of the instrument to the mouth. It is so designed in its construction that the lips shall not touch the metal work. The breath has then room to spread itself, and command the whole area of the instrument for its free egress and entrance: whereas many patients, by allowing the restraining tucks to be loose, apply the lips to the metal itself; thus they respire through a surface equal only to the area of the mouth half open, or not one-sixth of the whole. Some persons commit an absurd mistake, while wearing the ORAL RESPIRATOR, that of continuing to breathe through the nostrils, and not through the mouth; which must of course defeat its action. As the mouth does not dry with the RESPIRATOR on, and as it becomes the channel of comfort, the habit of respiring through it entirely is easily acquired by a little practice; while the *orinasal* RESPIRATOR is an efficient resource for those who desire to respire through both channels. It is particularly adapted for use in bed, and it must be considered a far preferable means of allaying night-cough, than the common habit of taking into the stomach deleterious compounds prepared by unauthorized empirics.

As a commercial man, he can assure the profession of the indispensable necessity, in the case of an article entirely novel, of repeatedly directing the attention of the public to all particulars regarding it. The announcement of it has been far too limited hitherto, arising from the feelings and retired habits of the inventor. A business so little set forward commercially, could only have grown to its present magnitude through the merits of the article itself.

Though, as a matter of business only, it might not be of importance what justifiable means were employed, J. T. TYLER is very desirous of falling in with Mr. Jeffrey's wish, that the progressive use of the RESPIRATOR should, as far as possible, take place through the profession. He is, therefore, anxious, by removing all ground of prejudice, to prevent a not unfrequent occurrence, that of patients being for a time dissuaded, through some apprehension on the part of their medical advisers, from using the RESPIRATOR; which they have taken to at length, upon their own judgment, with the greatest possible benefit. He would earnestly recommend such members of the profession to view the RESPIRATOR in the threefold aspect of its connexion with Physics, Mechanics, and Therapeutics. With respect to the first, it has been pronounced by men of great ability in science a singularly choice application of a physical principle, while it is the invention of a mind long devoted to the cultivation of science. In its mechanical aspect, it is the reduction of the physical principle to practice by several curious machines and processes, each a distinct invention in itself. An attentive examination of the whole work led to a spontaneous expression of admiration from the first authority in mechanics, written in high terms of commendation. With respect to its chief aspect, that of an adjuvant in medicine, many learned and liberal members of the profession have, in various works, expressed themselves in language abundantly favourable.

By removing a constant cause of irritation; by its peculiar fomenting effect, keeping the parts moist, as well as warm: by diffusing over the whole system warmth which would have been lost from the lungs; and by enabling the invalid to enjoy air and exercise out of doors, its effects have been not palliative only, but in a remarkable manner restorative.
