Editor's Choice

What we know and what we don't know

It seems extraordinary that in medicine we don't know clearly what we know and what we don't know. Archie Cochrane—the epidemiologist of almost blessed memory—suggested 20 years ago that medicine should compile a critical register of what is known, and now several groups are taking up his challenge. Iain Chalmers and others discuss (p 786) why Cochrane's agenda is so important and describe how the Cochrane centre in Oxford will “collaborate with others to assemble and disseminate a register of controlled trials.”

Once you know what you know there is also the problem of how to change practice, and Chalmers and others note that unsystematically conducted reviews in journals and textbooks have sometimes taken years to recommend treatments that a systematic review would have shown to prevent premature death and other treatments have been endorsed long after trials had suggested that they were useless or harmful. One way to disseminate good practice is through guidelines, and Andy Haines and Gene Feder review how effective guidelines have been (p 785). Two important messages are that writing them is easy but getting them to change practice is hard, while guidelines produced locally by the people who will use them tend to be much more effective than those produced nationally or internationally.

Sexual abuse of children emerges as a theme in this

issue. Figures published last week by the National Society for the Prevention of Cruelty to Children show that the number of British children on registers of those at risk of all kinds of abuse has trebled since 1973 (p 793). The report shows that abuse tends to be associated with bigger, more mobile, and poorer families, but an anonymous doctor describes in a personal view how he discovered that his daughter was being sexually abused (p 838). His message is that it can happen to anybody. Roger Robinson, meanwhile, reviews a powerful if overstated book on the Orkney child abuse scare. The book's author, a consultant paediatrician, argues that the British and American ways of handling sexual abuse are inferior to the Dutch method, where the emphasis is on healing within the family.

Finally, this issue carries the obituary of Dougal Swinscow, the long time deputy editor of the *BMJ*, who died last week. Many readers will know Dougal best as the author of *Statistics at Square One*, which has sold 80 000 copies. But he was also a world famous lichenologist and an expert on gardens. My most moving moment with Dougal was when he described listening to a radio account—on a mountainside in Norway—of the dropping of the atomic bomb. “I knew then,” he said, “that the world would never be the same.”
